"Working slot" includes all activities on both days. "Audit" includes a day of lecture and watching/asking questions the course-building/hands on portion of the seminar. Priority given in the following order: JUDGES needing the workshop, then JUDGES not needing, then prospective judges then exhibitors. Judge prospects must purchase the "working slot" option and perform all stages, or make separate arrangements with Robin Nuttall, for the workshop to count toward their judge certification or continuing education.

Participants' dogs may be brought on site for the workshop, but must be crated in vehicles. *Dogs brought on site by auditors may be asked to run courses submitted for Sunday course-building session Dogs brought by working-slot attendees will not run courses.*

Working slot entrants must also submit course designs to Sharon by email before JULY 23<sup>rd</sup>. **One complete single trial: Novice through Master with Crazy 8s between Open and Senior.** A diagram of the rings will be provided for the design exercise via a confirmation email. Before beginning, please refamiliarize yourself with the course design and map requirements as defined in the rule books.

**Courses sent after July 23<sup>rd</sup> will be rejected and you will be moved from a Working spot to an Audit spot – NO EXCEPTIONS!**

A copy of the Barn Hunt rule book will be provided to each working slot participant, as well as some note-taking material.

A light breakfast and lunch, and snacks and refreshments, will be provided to participants on both days. There are fast food restaurants available a short drive away.
