Upon roll call, Commissioners Bernie Cosby, Allen Huddleston, Cheri Joyce, John Simon and Mike Wally were present. Commissioner Virgal Woolfolk was present via Zoom. Commissioner Jerry Rust was absent. Others in attendance in person included Village Administrator/Clerk - Carla Ayala and Les Kauble [26119 Rynelle Drive]. Village Attorney - Nathan Bruns attended via Zoom videoconference.

#### ADOPTION OF AGENDA

Motioned by Commissioner Simon, seconded by Commissioner Joyce to approve the meeting agenda. All members present voted "Yea". Motion passed and approved with a 6-0 vote.

a. Non-Residential District Zoning Code Amendment - Discussion was held regarding the amendment. Commissioner Wally stated that changes proposed were obtained from the Wentzville guidelines. Commissioners to review the changes to discuss during the next meeting. A timeline was discussed. Next meeting feedback/updates, this could possibly take six months to complete. A public hearing will need to be held after changes are complete.

## COMMISSIONER ANNOUNCEMENTS

Chairman Huddleston stated that Wags and Whiskers has begun construction, but not according to the site plan on the Special Use Permit (SUP). A letter has been sent to Wags and Whiskers stating the non-conformities, and requests compliance with the Village Zoning Regulations and the SUP. In addition, Chairman Huddleston stated that he would like the Commissioners to pre-determine the next meeting agenda prior to adjourning each meeting going forward.
