

# Bloomfield Police Department

## Monthly Report for August 2019

This is the monthly report for the Month of August 2019 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

On Saturday, August 24<sup>th</sup> the police department held its annual "Kids Day Out" event at the Bloomfield Municipal Center. There was a total of 488 kids registered during the event

On Thursday, August 1<sup>st</sup> at approximately 3:05am while on patrol officers located a 27-year-old male lying in middle of Celadine Road. At the conclusion of the incident the male subject was arrested then confined in the Walworth County Jail. A charge of bail jumping has been forwarded to the Walworth County District Attorney's office.

On Thursday, August 8<sup>th</sup> at approximately 1:05pm officers along with the Bloomfield-Genoa City Fire & Rescue Department responded to a vehicle versus motorcycle crash on Hwy 120 north of Hwy H. At the conclusion of the investigation 29-year-old female was arrested then confined in the Walworth County Jail. Charges of causing injury while operating a motor vehicle while intoxicated and operating after revocation have been forwarded to the Walworth County District Attorney's office. Additionally, the driver was issued traffic citations for non-registration of a motor vehicle and operating without insurance. As a result of the investigation a 24-year-old male was also arrested then confined in the Walworth County Jail. A charge of 1<sup>st</sup> degree recklessly endangering safety was forwarded to the Walworth County District Attorney's office.

On Friday, August 9<sup>th</sup> officers responded to Pioneer Estates, N2020 Hwy H for a road rage type traffic complaint which had occurred on Hwy H. At the conclusion of the investigation a 48-year-old male was issued a non-traffic citation for disorderly conduct.

On Saturday, August 10<sup>th</sup> at approximately 1:20pm officers executed a traffic stop on Lakeshore Drive for a traffic violation. At the conclusion of the traffic stop a 33-year-old male was issued a traffic citation for failure to obey traffic officer/signal and operating without a valid driver's license.

On Sunday, August 11<sup>th</sup> at approximately 12:55pm officers received a road rage disorderly conduct complaint which had occurred in the area of N. Lakeshore Drive at Orchid Drive. It was reported that during the incident one of the male drivers retrieved a hammer from his vehicle then began to smash the windshield of the other vehicle. The male subject with the hammer then threw it through the rear driver's side window returned to his vehicle and drove away. There were not any injuries reported during the incident. This incident remains under investigation.

On Monday, August 12<sup>th</sup> at approximately 5:50pm officers executed a traffic stop on Nippersink Road in the area of Tombeau Road. At the conclusion of the of the traffic stop a 32-year-old male driver was issued a non-traffic citation for disorderly conduct with a motor vehicle and traffic citations for operating after suspension and operating without insurance.

On Tuesday, August 13<sup>th</sup> at approximately 9:14am officers received a criminal damage to property complaint which had occurred at the Pell Lake Laundromat. At the conclusion of the investigation a 30-year-old male was issued a non-traffic citation for criminal damage to property.

On Tuesday, August 13<sup>th</sup> at approximately 5:32pm officers executed a traffic stop on Tombeau Rd in the area of 101<sup>st</sup> St. for a traffic violation. At the conclusion of the traffic stop a 19-year-old female was issued a traffic citation for operating after suspension.

On Friday, August 16<sup>th</sup> at approximately 12:47am officers executed a traffic stop on Hwy 50 in the area of Eastside Rd for a speeding violation. At the conclusion of the traffic stop a 28-year-old male was issued a traffic citation for speeding. Additionally, a charge of operating after revocation was forwarded to the Walworth County District Attorney's office.

On Saturday, August 17<sup>th</sup> at approximately 1:35am officers executed a traffic stop for a suspicious vehicle driving from a closed business. At the conclusion of the traffic stop a 29-year-old male was issued a traffic citation for operating after suspension.

On Saturday, August 17<sup>th</sup> at approximately 2:14pm officers attempted to stop a motorcycle on Hwy 50 in the area of Eastside Road for a speeding violation. After a short pursuit the 24-year-old male motorcycle operator pulled over and stopped where he was taken into custody without further incident. The operator was confined in the Walworth County Jail. A charge of vehicle operator fleeing/eluding a traffic officer was forwarded to the Walworth County District Attorney's office. Additionally, the operator was issued a traffic citation for the speeding violation.

On Friday, August 23<sup>rd</sup> at approximately 12:09am officers responded to the area of Orchid Dr and Anemone Road for people yelling. At the conclusion of the investigation a 36-year-old female was arrested for operating a motor vehicle while intoxicated 1<sup>st</sup> offense. Additionally, a charge of bail jumping was forwarded to the Walworth County District Attorney's office for a 38-year-old male.

On Friday, August 30<sup>th</sup> at approximately 9:06pm officers responded to a residence in the 800 block of Roman Lane for a report of a fight. At the conclusion of the investigation a 36-year-old male and a 21-year-old male were issued non-traffic citations for disorderly conduct.

During the month of August 2019, the police department affected 181 arrests for various violations of Bloomfield Municipal Ordinances and Wisconsin State Statutes compared 142 arrests during the month of August 2018.
