AN ORDINANCE, providing for the issuance of internal improvement bonds of the City of Garnett, Kansas, to pay for the paving, curbing, guttering and grading of certain portions of certain streets and avenues in said city.

Whereas, in pursuance of preeceedings duly taken according to law, by the Board of Commissioners of the City of Garnett, Kansas, contracts have been let for the paving , curbing guttering and grading of Seventh Avenue from the West line of Main Street to the West boundry line of maid City on the South side of Seventh Avenue In said city.

whereas, all legal requirements have been fully complied with to authorize the issuance of bonds of said city on account of said improvements: therefore

Be it ordained by the Board of Commissioners of the City of Barnett, Kansas:

between the limits herein before described, there shall be issued a series of bonds of said City of Garnett, in the aggregate amount of \$11.844.66, which shall consist of one bond of \$1044.66, and nine bonds of \$1200.00 each, bearing interest at the rate of four and one helf per cent per annum payable semi-annually on his and January 1st. of each year and shall become due and payable as follows:

Section That said bonds shall be signed by the Mayor and attested

by the City Clerk and shall have the corporate seal of said city affixed thereto, that the interest coupons shall be executed with lithographed signatures of Mayor and City Clerk and that both bonds and coupons shall be payable at the office of the Treasury of the State of Kansas, in the City of Topeka, Kansas.

Section 3. That said bonds shall be executed in the form and shall contain recitals substantially as follows:

That the City of Garnett, in the County of Anderson, State of Kansas, for value received, hereby acknowledges its self indebted to and promisebto pay the bearer the sum of DOLLARS; lawful money of the United States of America, on the first day of July A. D. 19 with interest thereon at the rate of four and one fair per cent (4-I/4) per annum, payable semi-annually on the first day of July January of feath year after the date hereof, untill the principal shall be paid, upon presentation and surrender of the proper interest coupons hereto attached as they show severally become due and both principal and interest are payable at the office of the Treasurer of the State of Kansas, in the City of Topeka, Kansas, and the City of Garnett is hereby held held and firmly bound and its faith and credit was all the real and personal property in said city are hereby pledged for the payment of the principal and interest of this bonds of maturity.

This hond is one of a series of Ten (10) numbered from one to ten inclusive aggregating the sum of (\$11,844.66) Eleven Thousand, Eight Hundred and Forty-four Dollars and sixty-six (66) cents, issued for the paving, curbing, guttering and grading of Seventh Avenue in said City, by the Authority of, and in accordance with the provisions of the laws of the State of Kansas, governing cities of the second class, and in compliance with the provisions of an ordinance duly and lagally passed, published and approved by the Board of Commissioners of said City.

And it is hereby declared and certified that all acts, conditions and things required to be done and to exist precedent to and in the issuing of this bond, have been properly done and performed and do exist in regular and due form as required by the Constitution and Laws of the State of Kansas, and that the total indebtedness of said city, including this series of bonds, does not exceed any constitutional or statutory limitations.
