

This meeting of the Board of Fire Commissioners, District 4, Township of Franklin, Gloucester County NJ was called to order on September 24<sup>th</sup>, 2024 @ 19:00 and attended by the members noted below. This meeting was called pursuant to the provisions of the Open Public Meetings Law. This meeting was included in a list of meeting notices sent to the Courier Post newspaper, filed with the Municipal Clerk at the Township of Franklin, County of Gloucester and posted at the Forest Grove Volunteer Fire Company.

#### 2. Reading of the minutes of the previous meeting

A motion to accept minutes as read was made by Thomas Bellone and seconded by Samuel Scapellato. No changes to be made.

#### 3. Treasurers Report & Bills against the Commission

Joseph Scapellato reported: Petty cash balance \$94.00

43-51's registration renewal was received and mailed.

Glenn Insurance contacted the Board to advise that the Workmans Compensation last installment payment was not received. Joseph Scapellato went to the bank and the check was deposited. Glenn Insurance will look into it farther.

A motion to pay all bills and to accept the Treasurers report was made by Andrew Bellone and seconded by Thomas Bellone.



### 4. Old Business

Mykola Myronowskyj reported on the following: Filing of documents that he can locate from 2011 and prior. The files that are being archived are being organized, then scanned and then filed.

At the NJ Fireman's Convention, Mykola Myronowskyj met with Tim Allaband of Matheny Motors, he and his team will be our new sales and contract contacts. The Board and Chief Dennis Allonardo are planning to now have a more in depth meeting with Mr. Allaband and his team in the near future.

The Chief is still working on obtaining the pricing for the proposed new brush truck. As soon as he receives it, he will submit it to the Board for review. Currently the proposed price is approximately \$240,000.00 with a ballot question request not to exceed \$290,000.00. The Board reviewed the request and due to budgeting, we are not approving the full purchase of a brush truck. The Board will meet with the Chief and advise that his request as written was being questioned and that a lower cost vehicle should be no more than \$150,000.00 needs to be considered as an option.

The Chief and a few officers had requested that a tandem axle 20' enclosed trailer be purchased. The idea was that the ERV and all of the equipment on 43-57 would now be transported in the trailer to operational locations. The ERV trailer would be traded in with a value of \$1,500.00. Mr. Myronowskyj rejected this idea since the intrinsic value of the trailer was worth more that the trade in value. He suggested that a smaller enclosed trailer be purchased for the equipment in 43-57 and leave the ERV on the existing trailer. This would accomplish multiple goals, including ease of towing, having the ability to have the ERV in one location and the other equipment in another, additionally the cost of a new trailer would be much less since the gross vehicle weight would be less. Since he department has multiple vehicles that can toe either trailer, it also makes logistical sense. The Board agreed, and we advised the Chief accordingly. The Chief provided price quotes from multiple sources and a 7x12 enclosed trailer was approved. The Chief was waiting for one more price quote. The best price to date is from Cross Roads Trailer sales, deal 105564 in the amount of \$6,843.00. Andrew Bellone tabled the approval of the PO pending the final quote, purchase order 7084.

The Board received another email confirmation that the erroneous amount that is owed has been waived and our account closed.



### 5. New Business

Resolution 2024-04 for the 2025 Commissioners compensation was reviewed, this resolution will be sent to the town council for review and approval. The vote was unanimously approved.

The 2025 proposed budget was approved and will be sent to the auditor for review.

An application from Tyler Tarquinio was received. He was a previous member and wishes to rejoin. His application was approved and will be given to the Chief for further processing.

The old fuel cards for Phillips 66 suddenly stopped working, Mykola Myronowskyj contacted the Gill Energy account representative, he immediately issued new cards and shipped them overnight. Mykola Myronowskyj tested the cards and the new fuel cards seem to be working properly.

Approving 2025 Annual Compensation for the Commissioners of the Franklin Township Fire District No. 4

WHEREAS, N.J.S.A. 40A:14-88 requires the municipal governing body to review and approve such compensation before the fire district can submit its annual budget to the voters, or, in the case of fire districts whose Board of Fire Commissioners elections coincides with the November General election, before the district can adopt its annual budget.

WHEREAS, the fire district must seek annual approval of elected commissioner compensation from the municipal governing body regardless of whether the Board is modifying the amount of compensation.

WHEREAS, the Board of Fire Commissioners of the Franklin Township Fire District No. 4 have proposed annual compensation for various members of their Board of Fire Commissioners for 2025 as follows:

Chairman:	\$ 1,900
Vice Chairman	\$ 1,900
Treasurer:	\$ 2,150
Secretary:	\$ 2,150
Commissioner:	\$ 1,900
