The Washoe County School District ("District" or "WCSD") is in receipt of your Freedom of Information Act ("FOIA") request dated September 29, 2016. As stated in this Office's October 6, 2016 letter, FOIA does not apply to state agencies. As such, your request was processed under Nevada's public records statutes, NRS 239 et seq. Your requests and the District's responses are as follows:
