CEO Message

We continue in 2020 with our plans to expand our service to you. We will be breaking ground early this spring on a new branch (our second!) at the corner of Heritage Hills Parkway and Soncy. If construction finishes on schedule, we will be opening in early fall (hopefully by Labor Day). We are excited about providing expanded convenience and services for those members and city employees who live in the area. In preparation for this grand transformation of the credit union, we will be rolling out expanded services in 2020. In the second half of the year we will: (1) Offer an expanded checking account program including a money market account, (2) Provide expanded overdraft protection services and quick loans between pay periods, (3) Evolve our real estate lending programs, and (4) Continue offering the strongest certificate of deposit rate programs. Let me thank you. City FCU has achieved significant success helping each of you with your credit union. We have provided loans for almost 1,000 members this year totaling \$7 million dollars. We have grown our membership by almost 300 persons. We also are the strongest financially we have ever been with \$4.2 million in capital and almost \$50 million in assets. This is your credit union. Annual Meeting Date Set

The Grand Plaza will once again be the location for this year's Annual Meeting to be held Tuesday, March 3, 2020, at 6:30 p.m. A catered Barbecue dinner will be served followed by the business meeting and cash prize drawings. Come out, visit with other members and enjoy the dinner.

Board Election Notice

There are four Board positions to be filled at the annual meeting, March 3, 2020.

The nominating committee has submitted the names of Thomas Higgins, Cinda Johnson, Marc Lusk, and Anthony Sena to fill four vacancies, on the Board. In addition to names submitted by the nominating committee, credit union bylaws provide for nomination from the membership. A petition signed by at least 35 members may submit other names.

The deadline for filing a petition with the credit union Secretary is January 31, 2020. If petitions are received, resulting in more than one nominee for each position to be filled, ballots will be distributed to eligible voters attending the annual meeting, March 3, 2020.

Election shall then be determined by plurality vote. If no petitions are received and there is only one nominee for each position to be filled, those nominated shall be elected by general consent of acclamation. Nomination from the floor at the annual meeting shall not be permitted.

75 Days Prior to the Annual Meeting. The secretary shall notify in writing all members eligible to vote that nominations for vacancies may also be made by petition signed by one percent of the members with a minimum of 20 and a maximum of 500.

The written notice shall indicate that the election will not be conducted by ballot and there will be no nominations from the floor when there is only one nominee for each position to be filled.
