AN ORDINANCE ANNEXING CONTIGUOUS TERRITORY TO THE TOWN OF CLOVERDALE, INDIANA.
PUTNAM COUNTY AUDITOR

SECTION I. Be it ordained by the Board of Trustees of the Town of Cloverdale, Indiana, that the following described contiguous territory be and same is hereby annexed to and declared to be a part of said Town of Cloverdale, Indiana.

The following described real estate in Putnam County, Indiana to-wit:

A part of the West half of the Northeast quarter of Section Six (6), Township 12 North, Range Three (3) West, described as follows, to-wit:

Beginning at a point on the West line of said half quarter which is 1366.10 feet South of the Northwest corner thereof; thence East parallel to the North line of said half quarter 710.82 feet to a point; thence South parallel to the West line of said half quarter 871.96 feet to the North right-of-way line of the Monon Railroad; thence Northwesterly along said right-of-way line to the West line of said half quarter; thence North or less, in Putnam County, Indiana. The above described real estate is recorded in Plat Book No. _____, Page No. _____.

SECTION II. That this ordinance shall be in full force and effect from and after it's passage and legal publication thereof according to law.

We, the undersigned owners of real estate situated outside the corporate limits of the Town of Cloverdale, Putnam County, Indiana, but adjacent and contiguous thereto, hereby petition the Town Board of said Town of Cloverdale to have annexed to said Town of Cloverdale the following described real estate, to-wit:
