### JUNE 5, 2017

The regular meeting of the Greenbush Township Board was called to order at 7:00 pm by Supervisor Thelen with the Pledge of Allegiance

Members present, Thelen, Smith, Roof, Kindel, Graham Absent none

<u>Agenda</u> was amended adding LED censor light, Newsletter for taxes insert, CAFR proceeds from garage sale Motion to accept agenda with the amendments by Kindel seconded by Graham motion carried

<u>Sheriff Report</u>- Eric Thompson all was quiet Greenbush Township a good township to be in. Sheriff Department upset over changes in the speed limit; they figure there will be more accidents.

Homeworks - Franchise Resolution - renewal of 30 year revocable contract for service to our township.

<u>Stoneco-</u> 5 year renewal of mining contract on Hall Road Residents around the affected area have a concern of dust and traffic, after comments on the subject by Stoneco and residents Greenbush board stated they had no objection to the renewal and Stoneco stated they would work on concerns.

<u>CAASA</u> – Rescue unit is up and running as of June 1<sup>st</sup>. It will be available for priority 1 and 2 call in Greenbush 1293 calls year to date, 183 Community Paramedic calls year to date. Working with Home Health Care to coordinate calls to be more efficient for residents using home health care services.

<u>Minutes</u> - Reading of minutes were dispensed and approved with the amendment of accepting bid packet until May 31, 2017 instead of June 5<sup>th</sup>, 2017. Motion by Kindel seconded Graham. Carried with amendments.

<u>Treasure's Report</u> - Roof thanked Patti Schafer for all her help and training of our new format, Quick Books. There will be no longer transfer of numbers to excel for treasures report all reports will be taken from quick books thus eliminating errors. Profit and loss statement every month also will be given.

Bills should be \$16,890.65 instead of \$12, 383.45 with check numbers 13089 - 13113

We took in \$82,486.04 from the sale of equipment and the garage sale of Fire Department assets. There is still \$5,000 to \$7,000 of equipment yet to come in.
