

Ordinance No 598

AN Ordinance Appropriating certain moneys.

Be it ordained by the mayor and commissioners of the city of Garnett Kansas.

Section One:- that the sum of *Fifteen Hundred and Eighty Eight and 8/100* ^{\$15788.80} Dollars be and the same is hereby appropriated out of the Water Works Extension Bond Fund 1913. in the hands of the city treasurer to pay the bills allowed against said fund at a regular meeting of said Board held on the first day of June 1914. A list of which may be found on page 152 of the journal of the proceedings of the Board on said date

Section Two:- that the sum of *Four Hundred and Seventy Eight and 4/100* Dollars be and the same is hereby appropriated out of the Electric Light Bond Fund 1913. in the hands of the city treasurer to pay the bills allowed against said fund at a regular meeting of said Board held on the first day of June 1914. A list of which may be found on page 153 of the Journal of the proceedings of the Board on said date

Section Three:- that the sum of *One Hundred and Forty Six and 4/100* Dollars be and the same is hereby appropriated out of the General funds in the hands of the city treasurer to pay the bills allowed against said funds at a regular meeting of said Board held on the first day of June 1914. a list of which may be found on page 151 of the Journal of the proceedings of the Board on said date

Section Four:- that the sum of *Ninety and 65/100* Dollars be and the same is hereby appropriated out of the water works Funds in the hands of the city treasurer to pay the Bills allowed against said funds at a regular meeting of said Board held on the 1st day of June 1914. a list of which may be found on page 151 of the Journal of the proceedings of the Board on said date

Section Five:- that the sum of *One Hundred and Ninety and 59/100* Dollars be and the same is hereby appropriated out of the Street Fund in the hands of the city treasurer to pay the Bills allowed against funds at a regular meeting of said Board held on the 1st day of June 1914. a list of which may be found on page 153 of the proceedings of the Board on said date.

Section Six:- that the sum of *One Hundred and Twenty Six and 45/100* Dollars be and the same is hereby appropriated out of the Electric Light Fund in the hands of the city treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held on the 1st day of June 1914. a list of which may be found on page 152 of the Journal of the proceedings of the Board on said date.

Section Seven:- that the sum of *Four and 110/100* Dollars be and the same is hereby appropriated out of the funds of sewer District number (One) to pay the Bills allowed against said funds at a regular meeting of said Board held on the 1st day of June 1914. a list of which may be found on page 152 of the proceedings of the Board on said date.

Section Eight:- that ~~the~~ mayor and city clerk are hereby authorized and instructed to draw warrants on the city treasurer to pay the Bills allowed in the foregoing sections of this ordinance number to wit:- Sections One. Two. Three. Four. Five. Six. and ~~Eight~~. *Seven*

Section Nine:- that this ordinance shall take effect and be in force from and after its passage by the Board of Commissioners and its approval by the mayor
