Cars to be used initially in the Rookie class and with prior approval may be used in progressive classes in accordance with Rookie graduation procedures.
 Recipient will be responsible for repairs, regular maintenance throughout racing season.
 Recipient must be able to store and transport car to and from the track each week.
 Recipient must agree to bring car to and participate in all Arrive and Drive events.
 Recipient must agree to participate in at least 75% of CIQMA events throughout the season. Missing 3 consecutive events will revoke this agreement and car will be returned to CIQMA.
 Recipient will be responsible for purchase of approved driver safety equipment: Helmet, gloves, suit, arm restraints, neck restraints.
 Must join CIQMA as full member and comply with all membership requirements including the \$25 weekly entry fee.
 Recipient must join CIQMA and USAC as full member and comply with all membership requirements including \$100 annual USAC membership fee, and \$85 CIQMA annual membership fee.
 Member must pay a \$200 refundable deposit at the time of pick-up. Funds will not be refunded if car is not returned in a condition/value like it was received.
 Paint and decaling on car must be maintained throughout the racing season.
 CIQMA reserves the right to revoke this agreement for any reason and pursue necessary means to ensure return of all CIQMA property.
 Upon awarding of scholarship car, family will be loaned a quarter-midget and pit cart in race ready condition, said car and cart is the sole property of CIQMA and must be returned in like condition by November 1, 2015.
