Voting in Iowa County

vember 5. If you have questions about how, where and when to vote in the general election look at the Iowa County Auditor's website at iowacounty.iowa. gov. Then go to the "Elections and Voting - How to Vote" page. Remember there is an Iowa County, Wisconsin so when searching on the web for our lowa County Auditor, or any Iowa County office,

Or call the Auditor's Office at 319-642-7307. They are happy to answer questions.

You can check if you are registered to vote by going to the iowacounty.iowa.gov website and looking for the "Am I registered" button on the website which takes you to the Iowa Secretary of State web-

If you have an absentee ballot, fill it out and mail it soon. Mail in ballots must be received at the Auditor's Office by November 5 to be counted.

Early voting in person: You may pick up an absentee ballot or you may take your filled in absentee ballot to the Iowa County Auditor's Office at the East Annex at 970 Court Ave. Marengo (across the street from the Courthouse) before or on Monday, Nov. 4. Bring your ID with you to the Auditor's Of-

Your filled in ballot will be placed in sealed envelope and stored until election day. On election day, your ballot will be opened by a bipartisan team of election workers, separated from anything identifying who the ballot belongs to, and counted. Inperson absentee voting typically ends the day before an election. Check with the Auditor's Office for more information if you are unsure.

The only way to vote on election day, November 5, is by casting a vote at your assigned polling place. Visit the lowa county website or check the lowa Secretary of State of sos.iowa.gov page for the "Find Your Polling Place" page. The polls will be open 7 a.m. until 8 p.m.

Middle Amana Fire Station - Lenox and Iowa precincts vote at the Middle Amana Fire Station.

Hilton Township Hall in Conroy - Hilton and Washington precincts vote at the Hilton Township

You must bring an acceptable for of ID when voting. Acceptable forms, according to the Iowa County Auditor's website include, an Iowa Driver's License (not expired for more than 90 days); an lowa nonoperator ID (not expired for more than 90 days); a US Passport (not expired), a Voter ID card (must be signed) or a US Military or Veteran ID (not expired) or a Tribal ID card (must be signed with a photo).

If you do not have a driver's license or a non license ID from the state, you may obtain one of the new Voter ID cards. To do so, you may call the lowa County Auditor's office to have one sent to you. These Voter ID cards are issued with a fourdigit PIN to be used for voting.

Voters who do not have an acceptable form of ID will be allowed to either cast a provisional ballot or have another registered voter attest to their identity. Attesters must provide proper identification for themselves. If a provisional ballot is cast the election workers will provide instructions as to how the vote will be validated - meaning when and where the voter must provide an acceptable form of identification.


