Active Aggressor training with Reynoldsburg Police Department will be in late August or September. The training will begin in the classroom and then move to scenarios. M161 is back from Braun after the accident - approximately \$80,000 in repairs. Medic Order Update: new medic on order is now expected March of 2025; chassis is expected December 2024. We are going to explore other options to see if there is sooner availability.

Department is being forced to dissolve the car seat installation program. It has become too difficult to recertify members and Mount Carmel still has a program.

Department Officers participated in Working with Multiple Generations training from the OSU Leadership Center. The training was beneficial and would like for the rest of the department to participate at some point as well.

Per the press release, Truro has received the grant for Ohio First Responder Recruitment and Retention program in the amount of \$156,000.

Mausoleum Project Update – Masonry work is ongoing of tuck-pointing and roof work is scheduled to begin next week.

Decided against filing for the flagpole replacement grant of \$2,500. The application is more in depth than initially anticipated and needs historical data. Able to fix up the
