# UNIFORMED PATROL DIVISION



Lieutenant Ryan Acey is the Acting Patrol Division Commander. It is supervised by Sergeant Adam Cofield, Sergeant Eric Bertram, Sergeant Josh Bunch, and Sergeant Adam Cornwell. In addition, Corporals Beale, Hancock, Deacon, Nicholson, and Marshall assist with supervision. Uniformed Patrol is comprised of 32 deputies. The division provides 24-hour law enforcement services to the citizens of Isle of Wight County. Patrol deputies actively patrol the county and are dispatched to emergency calls and routine calls. They do patrol checks of neighborhoods, businesses, and schools daily in addition to being responsible for conducting both criminal and traffic crash investigations. Not only do they provide law enforcement services, write comprehensive reports, and traffic summons; they also work with the community to prevent crime, proactively address traffic concerns, and partner with community organizations to address their concerns.

flow to include incident reports, crash reports, traffic summonses, criminal warrants, case files, and civil process documents. Another critical function of this division is to ensure Virginia State Police, and other agency requirements are fulfilled for submissions of incident reports, crash reports, and warrant clearances. Crime analysis, statistical analysis, special projects, crime prevention, applicant fingerprinting, and technical services are also functions of this division.

In 2023 the unit began working with our new CAD/RMS vendor, 365Labs, to build and implement a state of the art system. It's been a long journey and we hope to have both up and running in 2024.



The Investigations Division is commanded by Lieutenant Susan Morgan and supervised by Sergeant Alex Johnson. There are six deputies assigned as investigators. Sergeant Johnson is new to the unit this year along with Investigator Rashiem Franklin. Investigators Hanley and Franklin are general investigators in the unit with Inv. Hanley having additional duties in Property and Evidence. The unit is multi-disciplinary. The team meets and discusses cases for interagency responses and interventions. Cases include child sexual abuse, severe physical abuse and neglect, violent crimes, and fraud. All Investigators worked the three homicides in the county for 2023.

In the years first homicide a suspect was identified and arrested. He was charged with second degree murder and the use or display of a firearm in committing a felony. Investigators worked a second homicide, and the suspect was arrested and charged with second degree murder and breaking and entering with intent to commit a felony. The third homicide of the year left investigators with a suspect who was charged with second degree murder, possession of a firearm by felon, and maliciously shoot or maim with the intent to kill.

The unit also works with our law enforcement partners to combat crime on a regional level. Investigator Van Wassen continues to serve as a Task Force Officer (TFO) on a federal task force operated by the Department of Homeland Security Investigations. This task force enables the Sheriff's office to work across jurisdictional lines and to bring federal resources to bear on cases here in Isle of Wight County.

Investigator Haskins is assigned to the Meherrin Drug Task Force. In October 2023 Investigator Edwards also joined the Meherrin Drug Task force. This Task Force is made up of agents from the Virginia State Police, IOW Sheriff's Office investigators, Sheriff's Office detectives, Franklin Southampton Smithfield Police detectives, Department Department the detective from Emporia detectives, and a Department. In 2023 the task force worked 43 felony cases which resulted in 49 arrests and executed one search warrant. The total amount of illegal drugs seized totaled \$115,640.00.

The Sheriff's Office Gang Unit was developed to combat the growing gang issue in the county. Since its creation, the unit has filed multiple gang participation charges and classified dozens of street gang members and outlaw motorcycle gang members. Investigators also assisted NCIS and surrounding jurisdictions with gang related homicides and robberies.

Investigator Haskins and Investigator Edwards created a sharing network to keep surrounding jurisdictions informed on the activities of these gang members. Investigator Haskins and Investigator Edwards outside of the Task Force Team have also executed 10 search warrants involving Narcotics and three Gang related search warrants.

The Digital Forensic Unit and Lab operated by Investigators Matthew VanWassen and Sean Lacy continues to grow and work cases involving Child Sexual Abuse Material (CSAM) and Internet Crimes Against Children (ICAC). The Digital Forensic Unit Investigators had multiple electronic devices to examine from each of these cases to include cellphones, computers, hard drives, thumb drives, and GPS devices. This would include the Digital Investigators examining electronics involving CSAM for other jurisdictions that needed this service to further their investigations. Investigators Van Wassen and Lacy continue their work with the Southern Virginia Internet Crimes Against Children (SOVA-ICAC) Task Force and the National Center for Missing and Exploited Children (NCMEC) to investigate child exploitation cases. In 2023 the unit examined nine cell phone devices multiple devices pending with exam. investigators continue to work closely with our regional, state, and federal partners to protect the children of Isle of Wight County. Both have continued their training and recertifications.



K9 Pixel and handler, Investigator Sean Lacy, are a part of our investigations team and family. Pixel is an Electronic Storage Device (ESD) Detection K9. She is specially trained to recognize the unique chemical scent of electronic storage devices, such as USB drives, hard drives, SIM cards and cell phones. These small storage devices are easily hidden by predators and difficult to locate during search warrants by human investigators alone. The ESD Detection K9's ability to quickly locate evidence during investigations is immensely helpful in prosecuting offenders and identifying survivors. Pixel has had seven successful deployments in 2023. K9 Pixel assists with surrounding agency search warrants as needed and she was the first Electronic Storage Device Detection K9 in the Hampton Roads Region.

# COURT SERVICES DIVISION



The Court Services Division is commanded by Lieutenant Donnie Brown and supervised by Sergeant Mike Tuck. In addition, the unit is supported by four full-time deputies, Senior Deputies William "Clay" Byram and Earvin Myers, along with Deputies, Edmund Cook and William "Brian" Miller. The full time staff is supported by Deputy Richard Barger, Deputy Shella Leigh, Deputy Bryan Smith and Deputy Patricia Gwaltney in part-time positions.

This division is responsible for the safety and security of the courthouse and its occupants. This is done by controlling access and screening persons who enter the building and by mitigating any security concerns that may arise. The unit works closely with other departments in the courts building to provide law enforcement assistance.

# COURT SERVICES DIVISION

Deputies act as security for all court proceedings and protect all judges while in the courthouse. Prisoner security and safety is also provided while prisoners are temporarily secured at the courthouse for their court hearings and proceedings.

#### Other duties include:

The transportation of juveniles to and from detention centers.

Transportation of Temporary Detention Orders (TDOs) and Emergency Custody Orders (ECO).

Travelling out of state to Extradite fugitives arrested in other states and service of all Civil Process.

The unit provided court security and bailiff duties for 380 court hearings. 11,948 total civil papers served which include 141 Evictions, 24 Writs, Levies, and Repossessions, along with 8 extraditions.

#### **Improvements in 2023**

- Implemented Extradition Checklist and Prisoner Travel Bag.
- Installed shelves in all the courts to secure conference-call speakers.
- Installed shelves in prisoner holding area to secure the property of remanded subjects.
- Purchased additional pole Mirrors for building searches.
- Completed outfitting all courts with large screen TV's.



The Community Services Division was created in December of 2021. It is commanded by Lieutenant Ryan Acey and supervised by Sergeant Grayson Craun. The Community Services Division encompasses several duties including community relations, recruitment, the Chaplaincy Program, and the School Resource Officer Program. The Isle of Wight County Sheriff's Office is extremely committed to building a strong relationship with our community. The Sheriff's Office has been involved in multiple community events throughout the year. Some of these events included K9 demonstrations for schools and clubs, police car demos for birthday parties, community festivals, rock wall amusement, Citizen Response to Active Shooter Event courses and multiple career days.

The Sheriff Office also continues to make great strides in keeping our elderly community safe. Unit deputies conducted presentations at our local AARP Association meetings as well as TRIAD meetings. These presentations consist of education on fraud and safety of the elderly community. We also maintain a partnership with Project Lifesaver to provide tracking devices to those who qualify for the service, free of charge. The Sheriff's office hosted its annual National Night Out event in the Benns Grant community. The event brought a large amount of the community and law enforcement together for fun and entertainment. All deputies are committed to building this strong bond with our community every day they are on shift. We know without the support of our community this job is impossible!

















#### SCHOOL RESOURCE OFFICERS

The Sheriff's Office places great emphasis on the safety and security of the students attending and employees working at our county schools. As such, deputies have full-time assignments in every school in the district. This was made possible through a grant from the Department of Criminal Justice Services.

Assignments throughout the day for our School Resource Officers (SRO) include, but are not limited to, safety checks of the school and school grounds daily, threat assessments, traffic control, monitoring pedestrian traffic in and out of school, all criminal investigations that occur on school property and much more.

SROs at primary school levels also instruct the D.A.R.E. program to all fifth-grade classes. The D.A.R.E. program teaches our youth essential decision-making skills, not only for substance abuse but for everyday life. Our SRO'S conducted 130 D.A.R.E presentation's in 2023. In addition to the full-time School Resource Officers, patrol deputies, administrators, and court services deputies routinely check the elementary schools throughout the school day to maintain a highly visible presence as well as interact with the students and staff. During the calendar year of 2023, this accounted for 386 checks totaling 256 hours of additional law enforcement presence within the schools.

# PROFESSIONAL STANDARDS AND PUBLIC RELATIONS

Deputy Alecia Paul is the Accreditation Manager and is supervised by Captain Thomas Potter. Mrs. Jimmie White also assists with accreditation. The Isle of Wight County Sheriff's receives Office their accreditation status from the Law Enforcement Virginia **Professional** Standards Commission (VLEPSC).



As accreditation is an on-going process, the Sheriff's Office must constantly meet criteria set forth by VLEPSC to maintain accredited status. Deputy Paul has the task of maintaining the files of proofs that show the sheriff's office is current in and stays in compliance with all standards as well as ensuring policy is current and consistent with the Code of Virginia.

There are currently 192 accreditation standards divided into four general subject areas: Administration, Operations, Personnel, and Training. Accreditation Assessment is a thorough examination of the previous four years of Sheriff's Office policy, procedures, and activity by three trained assessors (from other law enforcement agencies throughout Virginia),

commissioned by the Virginia Law Enforcement Professional Standards Commission (VLEPSC) to audit our agency. Deputy Alecia Paul is currently a Senior Assessor and Mrs. Jimmie White is a Master Assessor. Both travel throughout the commonwealth assisting and assessing other law enforcement agencies. They participated in six mock assessments and four, three-day on-site assessments.

#### **Public Relations**

Captain Thomas Potter and Deputy Alecia Paul serve as the Information Officers agencies' Public (PIO) responsible for all media relations for the office. This includes assisting news personnel in covering routine news stories, and at the scenes of incidents. They prepare and distribute agency media releases, are available for on-call responses to the news media and arrange and assist at news conferences. Both carefully coordinate and authorize the release of information about victims, witnesses, suspects and the release of information concerning confidential agency investigations and operations, along with managing and monitoring departmental social media accounts. there were 14 press releases disseminated, 44 media queries and one press conference.

# Animal Services Division



Isle of Wight County Sheriff's Office Animal Services is supervised by Chief Roy Richards under the direction of Major Joseph Willard. They're fully staffed at a strength of eight, to include a new position of Shelter Manager. Animal Services is charged with the enforcement of all Commonwealth of Virginia Laws, regulations and County ordinance for the protection of domestic animals that reside in Isle of Wight County. Animal Services is also responsible for the care and maintenance of the domestic animals that come into the facility. Those animals are housed for the required time frames and permanent homes are sought for those that are suitable for adoption or transfered to rescue organization.

#### <u>Civilian Records Management</u> Team



Mrs. Jimmie White, the Executive Assistant to Sheriff James R. Clarke, Jr., supervises the Sheriff's Office civilian Records Management Team. The team is composed of Mrs. Tammy Brown, Ms. Glenda Bridges and Ms. Marcella Proctor. They are responsible for the agency's financials, tracking all warrants, traffic summons, traffic crash information, civil process, case files, National Crime Information Center (NCIC), and Virginia Crime Information Network (VCIN). The Records Management Team does more than log and file legal papers. They are the first line of information for the public coming to our headquarters. They greet visitors, do fingerprints for various local organizations along with fielding questions and directing citizens to the appropriate units for assistance.


#### **K9 Teams**

In 2023 all five K9 teams of the the Isle of Wight County Sheriff's Office were certified through Virginia Police Work Dog Association (VPWDA). All K9 and handler teams go through rigorous training, attending a specialized K9 school for each discipline they possess. Each discipline requires a minimum of 400 training hours (3-month school). While all of Isle of Wight Sheriff's Office K9's are important to us, they do not serve just us. Our K9's are called upon by all surrounding jurisdictions for assistance. This includes many Federal agencies that don't have this resource. There were 119 K9 deployments in 2023.

#### K9 Teams:

#### Sqt. Eric Bertram and K9 Nova

K9 Nova is specialized in Explosives Detection. K9 Nova is utilized whenever a bomb threat is called into any school, business, or other public location. K9 Nova has also been utilized in the search for elements of a crime when they pertain to firearms. This includes locating thrown or hidden firearms and locating spent shell casings.




#### Dep. Russell Warren and K9 Hades

K9 Hades is a fully trained Patrol K9 with a dual purpose in Explosives Detection. Being a patrol K9 means Hades is trained to apprehend dangerous suspects, track suspects via ground disturbance or air scent, perform article searches for evidence of a crime, area search for suspects in wooded areas, building searches for burglary suspects or hidden wanted subjects, and perform crowd control.



#### Deputy 1st Class Matt Forni and K9 Max

K9 Max is our Narcotics Detection K9. K9 Max is trained to sniff out dangerous narcotics on traffic stops, search warrants, and is called upon by road deputies and our Investigations Unit. K9 Max is also dual purpose in tracking. K9 Max was discovered at our very own Animal Shelter after he was abandoned in a trailer park. We saved his life and in return he now protects the lives of our citizens and deputies, daily.




#### Dep. Steven Peed and K9 Mack

K9 Mack is Isle of Wight Sheriff's Office bloodhound, used for tracking/man trailing. K9 Mack is used for tracking down dangerous felons, wanted subjects and missing persons (children/elderly/special needs). While we have other k9's that are certified for tracking, none will be as proficient and accurate as K9 Mack. Bloodhounds possess an inherent ability to naturally be proficient tracking K9's. Much of this has with their body's composure. Bloodhounds are genetically built for this type of work.



#### Inv. Sean Lacy and K9 Pixel

K9 Pixel is our Electronic Detection K9. K9 Pixel is one of only three Electronic Detection K9's in the commonwealth. The team is utilized primarily for and human trafficking child exploitation investigations. K9 Pixel is our most utilized K9 by federal agencies needing assistance. She was trained and fully funded by Operation Underground Railroad and Jordan Detection K9.

#### **Special Response Team**

The Sheriff's Office maintains a part-time 16-member Special Response Team (SRT) comprised of sworn members of the agency. During 2023, the team was activated 5 times. These operations included but were not limited to the following: Mutual Aid to State, Local, and Federal law enforcement agencies. They executed narcotics search warrants, served high-risk arrest warrants, and conducted operations in support of child exploitation and missions to combat illegal drugs.

The Team conducted 24 trainings in 2023. Examples of training during 2023 included:

- Entry drills
- · Marksmanship with the pistol and rifle
- · Select fire with the rifle
- · Less Lethal with bean bags and gas
- · Direct to threat active shooter
- · Low light marksmanship

- Flash bang
- Chemical munitions
- Breach training
- · Scenario based training
- · Hostage rescue
- · Self aid buddy care
- Officer down drills





## **Specialty Units cont.**

#### **Marine Response Unit**

The primary role of this agency's vessel and Marine Unit is to promote safe boating and enforce boating regulations through positive and proactive interaction with the boating community and to participate in any special events that may be assigned by the Sheriff or his designee.

Personal Watercraft are utilized for general marine patrol. They are most effective at, but not limited to: Detection of reckless watercraft operations, BUI checkpoints, no-wake zone enforcement and shallow water search and rescue. PWC's are operated in tandem with another Marine Unit vessel.

The Marine Unit was operational in 2023 from April - July and was deployed four times.

#### **Motors Unit**

The primary role of the agency motorcycle is to perform regular patrol, traffic enforcement, funeral escorts, and any special events that may be assigned by the Sheriff or his designee.

One such assignment in 2023 was in honor of National Police Weeks "Road to Hope". Isle of Wight Motors Unit escorted over 200 bicyclist to Washington DC, honoring Law Enforcement Officers who made the ultimate sacrifice.

The Motors Unit participated in eleven functions.


