**RESOLUTION NO.: SL - 52 - 2023**

**TITLE: Approval of Contract with Progressive Pest Management for  
Invasive Weed Control at the Reservation**

**WHEREAS**, the Summit Lake Paiute Tribe is organized pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 8, 1965, granting certain powers to the Summit Lake Paiute Council; and

**WHEREAS**, the Summit Lake Paiute Council is the duly constituted governing body within the Summit Lake Paiute Reservation; and

**WHEREAS**, the Summit Lake Paiute Tribe is committed to the conservation of cultural and natural resources within the Summit Lake Indian Reservation ("Reservation") and to the long-term protection, preservation, and management of these resources; and

**WHEREAS**, the Summit Lake Paiute Tribe currently administers Bureau of Indian Affairs (BIA) grant (A20AV01054/Fund 152) to perform invasive weed eradication/control at the Reservation; and

**WHEREAS**, Progressive Pest Management offers weed eradication/control with herbicides in their portfolio of services and has worked with agencies such as BLM on large weed eradication/control projects with herbicide; and

**WHEREAS**, the Natural Resources Department has determined that Progressive Pest Management has the skills and experience to perform invasive weed eradication/control with herbicide at the Reservation and has provided a contract that meets the grant requirements and budget; and

**NOW THEREFORE BE IT RESOLVED** that the Summit Lake Paiute Council hereby authorizes, approves, and consents to entering into an Agreement with Progressive Pest Management.

**BE IT FURTHER RESOLVED** that the Summit Lake Paiute Council hereby authorizes the Tribal Chairwoman to execute the agreement with Progressive Pest Management and any other instruments as may be necessary and appropriate to accomplish the above-mentioned actions in the name of and on behalf of the Summit Lake Paiute Tribe.
