Sale Terms and Conditions:

- Only weanlings which are registered with a breed association shall be consigned to the MN 50/50 Sale.
- Weanlings consigned must be registered in a current member's name, or that of an immediate family member.
- In the event of an NSF check, the weanling will be returned to the consignor. The consignor may retain weanling's MN 50/50 eligibility by paying 50% of the weanling's sale price or 50% of the average weanling sale price from the current years' sale, whichever is less.
- Sale substitutions may occur up until the day of sale for sale entries that have been postmarked by 7/31/2024.
- All selling positions will be assigned to each weanling and weanlings will be sold in catalog order.
- Each current member will be assigned stalls for sale weanlings.
- Current members may consign up to 4 weanlings as voted upon by membership.
- **All sale weanlings are required to have original registration papers, signed transfer, and negative Coggins when checked into sale.** Health Certificates according to laws of your state and MN.
- All weanlings are expected to be fit and groomed to the best of their potential.

\*As a consignor, I am a paid member in good standing of the Minnesota 50/50 Futurity & Sale. I recognize that the MN 50/50 and R & J Horse Sales are only acting to provide a time and place for the sale of my horse. By consigning my foal to this sale, I recognize that this horse will be eligible to compete in the MN 50/50 Futurity in its 2 year old year.
