There being a quorum present Mayor Goodenow called the meeting to order at 7:00 PM.

Goals discussed in no particular order of importance were:

- Electrical hookups and coverage at Hand Dug Well area for Farmers Market
- Decorative lighting on Main Street
- Overlaying of Main Street
- Residential & business growth
- Housing Development
- City Park Improvements-outside restrooms
- Clean up of dilapidated structures
- Relocation of Tractor Supply from Manhattan to Westmoreland
- Keeping local businesses open
- Hardware Store
- Dollar General store
- Relationship between schools and community
- Upgrades to Fitness Center, promotion of the center, signage, wi-fi
- Lighting at Tennis Court, more usage
- Expansion of "Free Little Library" to the pool during summer
- Work on mini-library: hours, programs, events, etc.
- Better storm drainage in older parts of town, i.e. N. Walnut, N. 1st

- Something done with the Dechairo Clinic Building
- Get young people/families involved with city events, committees, etc.
- Signage for events at both entrances of town
