I, _____, the undersigned, do hereby agree to provide wine, beer, spirits, or cider tasting services at the Cohocton Fall Foliage Festival. The Cohocton Development Corporation agrees to permit such provisions of a wine/beer/spirit/ciders tasting service with a Farm Market Permit under the following conditions:

1. The Winery/Brewery/Distillery/Cidery (participant) agrees to participate in the wine/beer/spirit/ciders tasting event at The Fall Foliage Festival on Saturday, October 3, 2026 and Sunday, October 4, 2026 between the hours of 10:00 am and 5:00 pm on **both days**.
2. The participant shall set up its tasting area between **8:30 am and 8:45 am on Saturday**. The participant can strike their area after 5:00 pm on Sunday. The area must be totally cleared by 6:00 pm on Sunday, October 4, 2026.
3. The participant agrees to file with the Cohocton Development Corporation, no later than August 26, 2026, a **Certificate of Insurance with proof of at least \$1,000,000 of coverage naming the Cohocton Development Corporation, Town of Cohocton and Village of Cohocton as additional insured**.
4. The participant will not serve alcoholic beverages to people less than 21 years of age or who appear to be intoxicated. The participant shall be responsible for general cleanup in the service area during and after the festival. **No products will be left in the tent overnight**.
5. The participants are responsible to provide their own tasting cups.

Cohocton Development Corporation agrees to provide one 10x10 display space in a tent, one 8-foot table, ice and water for rinsing your cups.

Please return the **contract, application and Certificate of Insurance by August 26, 2026**. Space is very limited. For your Winery/Brewery/Distillery/Cidery to participate, it is understood that, by receipt of your application, you will participate and follow all rules and regulations established by Cohocton Development Corporation. Although there are no application fees, if it becomes necessary for you to cancel after acceptance, you will contact us as soon as possible so that your place can be filled by another participant.

The Cohocton Development Corporation, the Fall Foliage Festival Committee, the Town of Cohocton, and the Village of Cohocton are not responsible for any theft, loss of property, or personal injury suffered during, or as a result of your participation in the Fall Foliage Festival.
