Saturday July 26, 2025 10 a.m. to 7 p.m. Fallis Hall 53303 RR 52, Parkland County

To be **ELIGIBLE TO VOTE** in this election, you must:

- Be at least 18 years old, and
- Be a Canadian Citizen, and
- Reside in Alberta and your permanent place of residence is located within the Summer Village of Silver Sands on election day, or
- Be named on the certificate of title as the person who owns property within the Summer Village of Silver Sands, or
- Be the Spouse or adult interdependent partner of a person who is on the certificate of title as the person who owns property within the Summer Village of Silver Sands.

PLEASE NOTE: it is an offence under section 148 of the Local Authorities Election Act to vote in an election where you are not eligible. Any person who votes, knowing they are ineligible, could be fined up to \$10,000 or face imprisonment of not more than six (6) months.

PLEASE NOTE: Due to changes to the Local Authorities Election Act, VOUCHING will NOT be allowed in this year's Summer Village Election.

VOTER IDENTIFICATION REQUIREMENTS: Electors will be required to fill out Form 13 SV – Elector Register for Summer Villages and present one piece of identification authorized by the Chief Electoral Officer that establishes the person's name and current address.
