Friends of Carefree, we are six days away from the Carefree Property Tax election. If you have not mailed or dropped off your ballot, please drop off your ballot at the Council Chambers, 33 Easy Street, weekdays 8AM to 5PM, or on Tuesday, Election day, from 6AM to 7PM. Maricopa County Elections has advised that Ballot counting will begin on May 12th.

In the last Edition I mentioned that I would discuss the potential Carefree Property Tax rate and list other examples besides the simple example used by the administration. **Keep in mind that Property taxes are not based on the 'Market Value' of a property.** They are based on the **Limited Property Value (LPV)**, computed each year by the County and listed on your tax notice in August.

According to the town website, "A primary tax level of \$2.0 million would translate for the average home in Carefree with a Limited Property Value (LPV) of \$630,000, to \$55.67 per month or \$668 per year." Using that information, the calculated tax rate is .001060317, so an LPV of \$630,000 X .001060317 = 667.999 or \$668 per year additional tax. But not every property has an LPV of \$630,000. The simple table below illustrates the impact of a potential Carefree Property Tax based on different LPVs:

Check last year's tax notice to find *your* LPV, then find an LPV in the table above closer to your value to obtain a better estimate of what

your actual property tax increase will be, added to your current property tax. If you are among the Carefree elite, then perhaps an additional \$1,000 or more per year tax increase is not a worry. Can you say the same for all our residents? That is who the Council is supposed to consider when they propose their grand plans.

A final note, you may have had an encounter with Sarah Gondell at the Post Office over the past few months. She has been representing the pro-tax movement, possibly hired to do so. I mentioned her in the last Edition. Sarah lives at 7915 Primrose Path. Her support for a Property Tax is somewhat hypocritical considering she and her husband, Jean Jacques Chaltiel, failed to pay their own property tax in 2022.
