RESOLUTION NO.: SL - 49 - 2024

TITLE: APPROVAL OF CONTRACT WITH MORRIS AG AIR & SONS, INC. TO PERFORM AERIAL SEEDING FOR THE SAGEBRUSH HABITAT RESTORATION PROJECT (CONTRACT A23AV00724, SLPT FUND 168)

- WHEREAS**, the Summit Lake Paiute Tribe is organized pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 8, 1965, granting certain powers to the Summit Lake Paiute Council; and
- WHEREAS**, the Summit Lake Paiute Council has the responsibility for the general welfare of its tribal membership including tribal natural resources; and
- WHEREAS**, the Summit Lake Paiute Council is the duly constituted governing body within the Summit Lake Paiute Reservation; and
- WHEREAS**, the Summit Lake Paiute Council has been organized to represent, develop, protect, and advance the views, interest, education, resources, and general welfare of the Summit Lake Paiute Tribe membership; and
- WHEREAS**, the Summit Lake Paiute Council supports natural resources management that protects, conserves, and enhances plants and wildlife native to the Summit Lake basin and aboriginal area of the Summit Lake Paiute Tribe (SLPT); and
- WHEREAS**, the Summit Lake Paiute Council has organized a Natural Resources Department (NRD) to provide technical expertise and services to manage air, water, soil, fish, wildlife, plants, and infrastructure within the Summit Lake Paiute Reservation and off Reservation areas considered the aboriginal homeland of the SLPT; and
- WHEREAS**, the Bureau of Indian Affairs (BIA) approved (Contract A23AV00724, SLPT Fund 168) for the SLPT to contract aerial seeding services to meet the project's goals and objectives; and
- WHEREAS**, Morris Ag Air & Sons, Inc. possesses the skills and equipment to perform the above referenced work and anticipates completing the work per the project schedule (fall 2024); and
- WHEREAS**, the NRD and Morris Ag Air & sons, Inc. have previously worked together on this project; and

NOW THEREFORE BE IT RESOLVED that the Summit Lake Paiute Council hereby authorizes, approves, and consents to entering into an Agreement with Morris Ag Air & Sons, Inc. for the above stated purpose; and

BE IT FURTHER RESOLVED that the Summit Lake Paiute Council does not waive, alter, or otherwise diminish its Sovereign Immunity, whether expressed or implied, by virtue of this grant contract for any and all administrative or legal action which may arise directly or indirectly from the same. Furthermore, the Summit Lake Paiute Council hereby authorizes the Tribal Chairwoman to execute any instruments as may be necessary and appropriate to accomplish the above-mentioned actions in the name of and on behalf of the Summit Lake Paiute Tribe.
