To date, elected officials have met with representatives from Pennsylvania Department of Community and Economic Development. A tentative report was submitted for review and to provide guidelines for what to consider during the process of regionalization.

The managers and police chiefs have been meeting regularly to review all budget items. They will continue to meet until a tentative budget is ready to be submitted to the elected officials. This budget will be used to determine if the regionalization of our police departments will be feasible to both municipalities.
