

**AMELIA VILLAGE, OHIO**  
**Ordinance O-2015-18**

**AN ORDINANCE APPOINTING JACKIE SAMPLES III AS A PART-TIME POLICE OFFICER FOR AMELIA VILLAGE FOR A PROBATIONARY PERIOD AND DECLARING AN EMERGENCY**

**WHEREAS**, The Mayor of Amelia Village after conferring with the Interim Police Chief, has recommended the appointment of Jackie Samples III as a part-time police officer for Amelia Village, and;

**WHEREAS**, The Council of Amelia Village concurs in the appointment of Jackie Samples III as a part-time Amelia police officer.

**NOW, THEREFORE**, be it ordained by the Council of Amelia Village, Clermont County, Ohio, that;

**SECTION I.** Jackie Samples III is hereby employed as a part-time police officer of Amelia Village, effective March 24, 2015 at a starting salary of \$11.50 per hour.

**SECTION II.** This appointment is contingent upon Mr. Samples III passing pre-employment medical and/or psychological examinations and drug screening to ensure that Mr. Samples III is physically and mentally able to perform the duties of a part-time police officer.

**SECTION III.** Per Ohio Revised Code Section 737.17, Mr. Samples III shall serve a probationary period of six months, at such time the Mayor with the concurrence of Village Council shall remove him from the position or appoint him as a permanent police officer.

**SECTION IV.** Council hereby finds and determines that all formal actions relative to the passage of this ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION V.** That this Ordinance is hereby declared to be an emergency measure for the preservation of the public peace, health, safety and general welfare of the Village. The reason for such necessity is that the Police Department of Amelia Village has recently lost several police officers and this appointment will allow the Village to provide the necessary police protection to the citizens of the Village. Therefore, provided this emergency clause receives the affirmative vote of two-thirds of all members elected to Council, this ordinance shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise from and after the earliest period allowed by law.

Mrs. Gerber moved to suspend the rules requiring three readings on three separate dates.

Mr. Campbell seconded the motion.


