DuPont™ LANNATE® LV can be applied for control of brown marmorated stink bug on apples, barley, beans (succulent and dry), blueberries, field corn, sweet corn, peaches, pears, peppers, soybeans, tomatoes and wheat when populations reach locally determined economic thresholds. Consult the cooperative extension service, professional consultants or other qualified authorities to determine appropriate threshold levels for treatment in your area.

APPLICATION

Make applications at a rate of 1.5 pints per acre of LANNATE® LV in barley, field corn, sweet corn, soybean and wheat by ground or air. Apply a rate of 1.5 to 3 pints per acre of LANNATE® LV in apple, beans (succulent and dry), blueberry, peach, pear, pepper and

tomato. Apply to apple, blueberry, peach and pear by ground only. Applications to beans (succulent and dry), pepper and tomato can be by ground or air. Repeat applications of LANNATE® LV as necessary to prevent reinfestation from adults migrating into the crop. Consult the label for the minimum application interval for each crop. Brown marmorated stink bugs are very mobile pests. They may reinfest the treated area quickly. If another application is needed prior to the minimum application interval, use a different insecticide.

Use sufficient water to obtain thorough, uniform coverage. It is recommended to use a minimum of 20 gallons of water per acre for ground applications to row and vegetable crops and a minimum of 50 gallons of water per acre for applications to apples, peaches, pears and blueberries. For aerial applications it is recommended to use a minimum of 5 gallons of water per acre for row and vegetable crops.

Since LANNATE® LV is a fast acting contact insecticide, best results follow direct spraying of the target insect.

For control of brown marmorated stink bug, do not apply this product through any type of irrigation system.

PRECAUTIONS:

Apple: Do not apply within 14 days of harvest. Do not apply more than 15 pints of LANNATE® LV per acre per season. Do not make more than 5 applications per crop.

Barley and Wheat: Do not apply within 7 days of harvest. Do not apply more than 6 pints of LANNATE® LV per acre per crop. Do not make more than 4 application per crop.

Beans (Succulent and Dry): For succulent beans do not apply within 3 days of harvest of the beans and vines and within 7 days of harvest of the hay. For dry beans do not apply within 14 days of harvest. Do not apply more than 15 pints of LANNATE® LV per acre per crop. Do not make more than 10 applications per crop.

Blueberry: Do not apply within 3 days of harvest. Do not apply more than 12 pints of LANNATE® LV per acre per crop. Do not make more than 4 applications per crop.

Field Corn: Do not apply within 3 days of harvest for forage, 21 days of harvest for ears and stover. Do not apply more than 7.5 pints of LANNATE® LV per acre per crop. Do not make more than 10 applications per crop.

Sweet Corn: Do not apply within 0 days of harvest for ears, 3 days of harvest of forage and 21 days of harvest for stover. Do not apply more than 21 pints of LANNATE® LV per acre per crop. Do not make more than 28 applications per crop.

Peaches: Do not apply within 4 days of harvest. Do not apply more than 18 pints of LANNATE® LV per acre per crop. Do not make more than 6 applications per crop.

Pear: Do not apply with 7 days of harvest. Do not apply more than 6 pints of LANNATE® LV per acre per crop. Do not make more than 2 application per crop.

Pepper: Do not apply within 3 days of harvest. Do not apply more than 15 pints of LANNATE® LV per acre per crop. Do not make more than 10 applications per crop.

Soybean: Do not apply within 14 days of harvest for soybeans, 3 days of harvest for forage and 12 days of harvest for hay. Do not apply more than 4.5 pints of Lannate LV per acre per crop. Do not make more than 3 applications per crop.

Tomato: Do not apply within 1 day of harvest. Do not apply more than 21 pints of LANNATE® LV per acre per crop. Do not make more than 16 applications per crop.
