

ORDINANCE NO. 2014- / 10

AN ORDINANCE AMENDING THE TOWN CODE TO CLARIFY PERMIT REQUIREMENTS, FEES AND CHARGES

WHEREAS, the Town council of the Town of Cloverdale, Indiana (the “Town Council”) has determined that the Inspection Fees ordinance needs to be clarified and revised,

BE IT ADOPTED

That Section 7-60 of the Town Code be amended to read as follows:

The minimum permit fee for any permit or inspection shall be Thirty Dollars (\$30.00). For unusually large or complex buildings or structures, the Building Inspector shall have the power to increase the number of required inspections by fifty percent (50%). The Building Inspector shall, in all cases, designate the stage of construction when each required inspection must be requested by the permit holder. No concrete shall be placed for foundations without prior inspection. No electrical, mechanical plumbing or thermal insulation work shall be covered without prior inspection. Where additional inspections are required due to the failure of a permit holder to have work ready for inspections at a designated stage of construction the Building Inspector shall have the power to assess a re-inspection fee of Thirty Dollars (\$30.00) for each such additional inspection. Re-inspection fees shall be paid to the Clerk Treasurer prior to the issuance of a Certificate of Occupancy. The Building Inspector shall submit an annual report to the Town Council fo the Town of Cloverdale which shall include an analysis of the inspections preformed, permit fees collected, cost of inspection operations and recommendations for adjustment of required inspections and single inspection fees as necessary. Fees set hereunder shall superseded any fees previously in effect.

This ordinance supersedes and replaces any rule regulation or ordinance that conflicts with its provisions.

All remaining provisions in Section 7 remain in full force and effect.

This ordinance is effective as of the date of passage and publication as required by law. **ADOPTED and PASSED** on this 13 day of MAY, 2014.
