What is Hat Cutler Memorial Tournament?

This 2-person better ball team event is named after Hat Cutler, one of our founding women golfers in Northern Nevada. “Hat” was passionate about women’s golf and the opportunity to compete. This is a fun format, taking the better score of the partners on each hole. The tournament provides an opportunity to win overall gross or net, **OR** within your flight. So grab a partner, don a “Hat” for the Hat competition at the awards luncheon, and enjoy two days of golf with friends.

What is Team Match Play?

To many, the purest form of golf competition is Match Play. In this event six players representing one golf club are divided into three, 2-women teams. Each 2-woman team is allowed a maximum of 10 shots difference between handicaps. Your 2-woman team will play a 2-woman team from another club in a better-ball NET Match format. Each match is worth 18 points. Each hole is contested for one-point, with the winning team gaining one

point for winning the hole, and one-half point for each team when halving (tying) a hole. Every half-point matters as the winning club is the one with the most total points between their three 2-woman teams!! Let your Ladies Club President know you're interested in competing for your club in this fun team event!

High Sierra Team Play

Teams are selected from ladies who sign up and play on qualifying day. A team of six (the first 3 gross and first 3 low net) will compete against the other women's clubs at a different golf course each month. The Team Captain is exempt from qualifying and is always a team member unless she decides otherwise. Alternates are also selected from qualifiers in case someone cannot go.

If you belong to more than one women's club, you must choose which club you will be representing for the entire season. Once you "tee it up" for a given club, you must continue to play for that club for the rest of the year.

The format for Team Play is stroke play, using a quota system determined by your handicap (see chart on next page.) After scores are totaled for the game any points over the quota are a "plus" for the team; any points less than the quota are a "minus" for the team. The best five of the six team scores are counted for a total team score.

At the end of the season awards are given to 1st through 5th place.

ALL PLAYERS are RESPONSIBLE for READING and FOLLOWING the policy outlined below.

ALLOTTED TIME:

Groups are expected to complete each round in the time set forth on the scorecard. If a group is not maintaining proper pace, it will be considered out of position and subject to penalty.

OUT OF POSITION:

A group is out of position and subject to penalty when: 1) it is over the allotted time, AND 2) there is an open hole ahead, or when it has not yet begun a par 5 and the group ahead is on the green. Whether or not there is a group closely following the slow player(s) is irrelevant. Once a Rules Official becomes aware a group is out of position, that group will be warned and timing will begin. Groups out of position are expected to play faster and catch up. During their play of the next few holes, members of the group will be timed to see how long it takes them to play each shot. If the group fails to catch up either with the group ahead or with the allotted pace of play time, the slow players in a group may be penalized.

TIME LIMIT:

When out of position, a player taking more than 40 seconds to play a stroke may be assessed a penalty. Timing of a stroke begins when: the player is in the area from which she will play; it is her turn to play; and her line of play is clear.

PENALTIES:

When a penalty is assessed under Rule 6-7 (Undue Delay), a member of the Committee will notify the player and her marker. Penalties are as follows: in Stroke play, 1st Offense = 1 stroke. 2nd Offense = 2 strokes, Subsequent Offense = Disqualification.

If you are the first group in the field, play efficient golf and stay within the pace allotted. If you are in a following group, keep up with the group in front of you or stay on the pace allotted and you will not have a pace issue.

**This policy leaves responsibility for maintaining the pace of play where it belongs, WITH YOU, THE PLAYER.
THANK YOU FOR YOUR COOPERATION!**

“ELECTRONIC DEVICES”:

The use of an electronic device (such as a cellular phone, pager, hand-held computer, calculator, TV or radio) on the competition course is not itself a breach of Rule 14-3. However, players should ensure any device taken onto the course does not distract other players.

The following uses for cellular phone during a stipulated round are not a breach of Rule 14-3

- Using phone for matters unrelated to golf (e.g., calling home); Accessing information on advice related matters published prior to the start of the player's round (e.g., yardage book, swing tips);
- Obtaining information related to the competition being played (e.g., leader board, projected cut).

The following uses for cellular phones during a stipulated round are a breach of Rule 8-1 and will result in Disqualification:

- Using phone to ask for or give advice in breach of Rule 8-1 (e.g., calling a swing coach);
- Accessing information on advice-related matters not published prior to the start of the round.

Cell phone Etiquette: If the use of a cellular phone consistently disregards the etiquette guidelines (outlined in the Rules of Golf), the offending player will be issued a warning. **If the player repeatedly distracts or offends an opponent or fellow competitor by using a cellular phone the player will be disqualified under Rule 33-7.**

NNWGA Policy on Tournament Score Posting

Our new recommendation is that the clubs only post T- scores for events such as President's Cup, Club Championship and any other end of the season events where a Champion is identified. For example: Some clubs hold a monthly tournament to identify a gross and net winner to play in a season ending Championship. Only the season ending Championship would be posted as a T-score. If your Member-Guest/Invitational event has Mulligans, Magic Putts and/or Free Throws, they have to be posted, but not as T-scores. You no longer have to post HSTP Qualifying scores as T-scores. This policy is effective immediately.

EQUITABLE STROKE CONTROL (E.S.C.)

ESC **MUST** be observed by each player in order to have uniform USGA Handicap Indexes.

ESC IS NOT RELATED TO THE ALLOCATION OF HANDICAP STROKES TO THE HOLES OF A COURSE.

Under ESC, unusually high scores on individual holes are automatically adjusted downward so that the score posted is a more accurate representation of the player's ability. Remember, there is no limit to the number of holes reduced to this maximum score in a round. The following table will be used to set the maximum score for posting purposes:

18 HOLE COURSE HANDICAP	MAXIMUM # ON ANY HOLE
9 OR LESS	DOUBLE BOGEY
10 THROUGH 19	7
20 THROUGH 29	8
30 THROUGH 39	9
40 OR MORE	10

EACH PLAYER IS RESPONSIBLE FOR ADJUSTING SCORES IN ACCORDANCE WITH THE ESC PROCEDURE BEFORE POSTING FOR HANDICAP PURPOSES.

WHAT TO DO IF A PLAYER DOES NOT FINISH A HOLE

If a player starts but does not complete a hole, or a stroke is conceded, she shall record, for handicap purposes, the score she most likely would have made if the hole had been completed; but such score shall not exceed her ESC limit. The most likely score is the number of strokes already taken, plus in the player's best judgment, the number of strokes needed to complete the hole from that point more than half the time. The most likely score should have an "X" preceding the number on the scorecard. There is no limit to the number of unfinished holes in a round provided that failure to finish is not for the purpose of handicap manipulation.

WHAT TO DO IF A PLAYER DOES NOT PLAY A HOLE OR DOES NOT PLAY IT UNDER THE PRINCIPLES OF THE "RULES OF GOLF"

If a player does not play a hole or plays it other than under the Rules of Golf (i.e. using a mulligan or temporary greens), her score for that hole, for handicap purposes, shall be figured as follows:

The score for any of these holes is tossed out and replaced by a score of par plus the handicap strokes the player should receive on that hole. This score should have an "X" preceding the number on the scorecard.

**APPLICATION OF HANDICAP STROKES
OR "POPPING" YOUR SCORECARD**

When a competition requires that your Course Handicap be applied to the holes rather than deducted from the gross score, a player shall take them in the order assigned on the scorecard starting from the #1 Stroke Hole as follows: One stroke on each hole for handicaps 0-18, 2 strokes on any holes for handicaps from 19-36, and 3 strokes on any holes for handicaps from 37-54.

OTHER INFORMATION

A USGA Handicap Index will be issued to a player who has returned 5 or more 18-hole scores. Fewer than 5 scores = NH (No Handicap). A player without an established USGA Handicap Index shall use, for ESC purposes, an index of 40.4 converted to a Course Handicap until she has an established USGA Handicap.

The maximum USGA Handicap Index for women is 40.4. Handicap Indexes for women in NNWGA are computed higher; however, they are to be used only for intra-club play with the club's permission and are identified as a Local Handicap Index by the letter "L."

A player does not play with her USGA Handicap Index. Rather she converts it to a Course Handicap by using the appropriate Course Handicap Table and plays with her Course Handicap.

A multi-member shall use the Handicap Index on the most current NNWGA GHIN Master Handicap Index List when competing outside her club. If a multi-member has different USGA Handicap Indexes at her different clubs despite posting all her scores, the committee in charge of the competition should require her to use the lowest Handicap Index.

The club Handicap Committee has the right to adjust the handicap of a player who (a) consistently scores better in tournaments than in informal games, (b) does not turn in all scores, and © does not observe the spirit of the USGA Handicap System. In an extreme case of a player's non-cooperation, withdrawal of the handicap is required.
