COVID-19 has been a marathon nobody signed up for, but we're in the home stretch and the finish line is in sight. To encourage more people to get vaccinated, Lake County and Lake View are challenging organizations to bring at least 20 people together to get vaccinated. Organizations who succeed will receive \$50 per vaccinated person from State of Minnesota Vaccine Administration Grant Funds!

Register your team by May 26, 2021 by contacting Tracy Gilsvik at Lake County Public Health 834-8406 or tracy.gilsvik@co.lake.mn.us. The clock is running!

Who: Lake County non-profit organizations, churches, school groups, sports teams and businesses.

What: Invite people age 12+ who live, work or attend school in Lake County to get vaccinated. Encourage your members, classmates, friends, parents, grandparents, neighbors, leaders, coaches, co-workers, etc. to join your COVID-19 Vaccine Team.

When: Before June 19, 2021, when the next big marathon (Grandma's) starts in Lake County

Where: Anywhere in Lake County. Find at least 20 people and we'll come to your location as long as you have a large enough space.

Why: It will help all of us get back to normal as quickly as we can AND YOUR ORGANIZATION WILL EARN \$50.00 FOR EACH PERSON ON YOUR COVID-19 VACCINE TEAM THAT GETS VACCINATED. BONUS: If 70% of Lake County residents age 12+ have received at least one dose of vaccine before the first Grandma's Marathon runner crosses the finish line on June 19, 2021, each organization will receive a \$250 bonus!

GUIDELINES

1. You must have an established organization located in Lake County, Minnesota to be eligible for this promotion.
2. One team per organization. Your organization must choose one captain to coordinate your vaccination event with Lake County Public Health.
3. By May 26, 2021, your captain must register your organization's COVID-19 Vaccine Team with Lake County Public Health and choose a date, starting time and location for your vaccination event.
4. Each organization must recruit at least 20 people that live, work or attend school in Lake County to join their COVID-19 Vaccine Team and get vaccinated at their event.
5. Vaccination events may be cancelled if there are not at least 20 people registered 48 hours prior to the event. If an event is cancelled, the organization will not be eligible for financial incentives or a bonus.
6. If you have a location with adequate space to host a vaccination event, we will come to the location of your choice anywhere in Lake County. If you do not have a location with adequate space, vaccination events can be held at Lake View Hospital and Medical Clinic in Two Harbors or the Mary MacDonald building in Silver Bay.
7. Your organization will receive a check from Lake County Health and Human Services within 14 days of the date of your vaccination event.
8. This project is being funded with State of Minnesota Vaccine Administration Grant Funds.
