Three types of semen are available for this stallion:

1. Fresh semen for mares being bred and under the care of Kansas Center For Equine Reproduction (KsCER) and Dr. Shelby Hayden, a board-certified reproductive specialist (Theriogenologist).
2. Fresh-cooled (shipped) semen and frozen semen for all other mares. **Fresh-cooled semen will be available until July 2, 2019. Frozen semen will be available until August 30, 2019.**

Additional Fees:

1. Annual Non-Refundable Booking Fee for fresh or fresh-cooled (shipped): \$300
2. Fresh semen breeding at Kansas Center For Equine Reproduction (KsCER) by Dr. Shelby Hayden
 - a. \$175 per collection
 - b. Fees associated with breeding management and care of the mare. To obtain these fees, please contact Kansas Center For Equine Reproduction (KsCER) directly at 785-813-5922.
3. Fresh-cooled (shipped) **Fresh Cooled Semen will be available until July 2, 2019.**
 - a. \$375 per collection and shipment via FedEx Priority Overnight within the lower 48 states for semen collected Mon-Fri (delivered Tues-Sat). **We will NOT collect semen on Memorial Day, Monday, May 27, 2019 and Independence Day, Thursday, July 4, 2019.** Delivery by FedEx First Overnight or UPS Overnight Shipping are \$275 PLUS associated shipping fees with a minimum of \$375 per semen shipment (please call KsCER for estimates on shipping fees).
 - i. Semen shipments to Hawaii, Alaska, Mexico, and Canada if feasible will be determined on an individual basis by KsCER but do incur extra fees. Please call KsCER for requirements, details, and fees for shipments to these location and fees.

- b. \$275 per collection and processing for on-farm pickup from KsCER by 5 pm CT the day of semen collection.
- c. \$550 per collection, courier fees, and shipment via counter-to-counter delivery from Kansas City International Airport (MCI). KsCER has accounts with American, United, and Southwest Airlines.
- d. When available, Saturday semen collections will incur an additional \$100 fee and semen must be shipped via counter-to-counter. Thus, a total collection fee for Saturday semen collections is \$650.
- e. Valid credit card information and authorization to charge the credit card or a \$350 deposit to KsCER in the event that the Equitainer or any of its original contents are not returned with 7 days of shipment or are damaged. Unused portions of the deposit will be returned at the end of the breeding season.
- e. All fees for semen collection and shipment with fresh-cooled semen are due in full to KsCER prior to semen collection for shipment.

The annual non-refundable booking fee for fresh or fresh-cooled (shipped) semen, all semen collection and shipping fees, and all fees directly pertaining to mare management when breeding with fresh semen are payable to:

3. All fees for shipment of frozen semen are payable directly to Zoetis.

Frozen semen will be available until August 30, 2019

- a. Frozen Semen Shipment Fee: \$344.79 per shipment (as of March 2019 – fees are at the discretion of Zoetis)
- b. This fee includes preparation for shipment, vapor shipper rental, overnight priority delivery, 3 day return delivery, freight and administrative fees.
- c. Zoetis only ships semen out Monday-Friday on non-holiday dates.
- d. If the vapor shipper is not returned within 7 days there is a \$25.00 per day late fee will be charged.
- e. If the vapor shipper is unreturned, the charge is \$1300.00 for replacement.
- f. Under no circumstances should unused straws be returned in warm dry shippers.
- g. PLEASE NOTE: Frozen semen shipment fees are subject to the discretion of Zoetis. The aforementioned fees are Zoetis's fees as of March 2019. We cannot guarantee that Zoetis will honor these fees for the entire 2019 breeding season.

Fresh-cooled semen collection days are Monday through Friday and potentially (not guaranteed) on Saturday. Requests for fresh-cooled semen shipments should be made by calling the Kansas Center For Equine Reproduction (KsCER) at 785-813-5922. **All requests must be made by 3:00 pm CT the day before desired day of semen collection for shipment (NO EXCEPTIONS) when semen collection is requested from collections from Mon-Fri. If a Saturday semen collection is desired, requests must be made by 12:00 pm CT on Friday.** The availability for Saturday semen collection will depend on available personnel at KsCER on that Saturday. Semen must be cancelled by 8:00 am CT the day of desired collection. The

decision to have semen shipped by counter-to-counter or by FedEx Priority Overnight must be made no later than 8:00 am CT the day of desired collection. **We will NOT collect semen on Memorial Day, Monday, May 27, 2019 and Thursday, July 4, 2019**

Requests for frozen semen shipments should be made by calling Kansas Center For Equine Reproduction (KsCER) at 785-813-5922 Monday thru Friday from 8 a.m. to 5 p.m. CT. We highly suggest that semen shipments be requested prior to the desired cycle of breeding or a minimum at the beginning of the cycle of breeding. **Delivery of semen the day following request should not be expected.**

Frozen semen will be available until August 30, 2019.

The shipment of frozen semen will include 2 or 3 doses of frozen semen (per discretion of mare owner's veterinarian) to allow for either a single post-ovulation insemination or timed insemination protocols. Default quantity of doses shipped will be two if not specified at the time of frozen semen request. Instructions and information pertaining to the semen being shipped will be included with the semen. We highly recommend that insemination occur within 4-6 hours pre- and/or post-ovulation. We also highly recommend that a deep-horn insemination technique be utilized for all inseminations. **DO NOT, UNDER ANY CIRCUMSTANCES, USE LESS THAN ONE DOSE OF SEMEN PER INSEMINATION.**

This mare is booked by name. The booking is valid to the mare named. If the mare becomes unable to breed or passes away, the booking can be transferred with the approval of the stallion owner. This contract to the above mare cannot be sold by the mare owner.

If the mare fails to produce a live foal, return privileges are guaranteed the following year or the stallion fee will be refunded per the stallion owner's preference. If the foal is born dead, the mare owner agrees to furnish the stallion owner, within 30 days, a veterinarian certificate describing the occurrence.

Rebreeds must pay any applicable booking fees, semen collection fees, or shipping charges applicable. If the mare aborts or fails to conceive, additional fresh-cooled and/or frozen semen are/is available for shipment or the mare can be rebred with fresh semen at Kansas Center For Equine Reproduction (KsCER) during the current breeding season. If it becomes too late to re-breed a mare during the current season, she may be bred the following year only if agreed in writing and signed by both parties.

It is the mare owner's responsibility to provide the Kansas Center For Equine Reproduction with the last breeding date of frozen semen and information on the number of straws utilized and the number remaining. If any remaining straws were unused,

The mare owner agrees to have the mare checked, by transrectal ultrasound, no later than 15 days post-ovulation by a licensed veterinarian with expertise in equine reproduction. An additional transrectal ultrasound examination confirming presence of viable pregnancy (embryo with a heartbeat) is also required before 40 days of gestation by a licensed veterinarian with expertise in equine reproduction. The mare owner agrees to provide the Kansas Center For Equine Reproduction with the results of the pregnancy exam no later than 45 days after insemination and the last breeding date.

Neither the stallion owner, managers, farm, nor its employees shall be liable for injury, death, or disability suffered by the mare, from any cause whatsoever, while in the custody/care of Ever Glades Farm, INC or

Kansas Center For Equine Reproduction (KsCER). The owner specifically assents to such condition and waives each and every claim for damages resulting from such injury, death or disability.

All charges, including transportation, board, veterinarian fees, as well as any and all related medicines or medicinal supplies etc., are to be paid by the mare owner.

Mare owner is responsible for safe and complete return of all dry/vapor shippers and the contents used for frozen semen shipments to Zoetis.

The stallion managers reserve the right to reject any mare not in good physical condition. The stallion managers also reserve the right to reject any mare that fails to produce a live foal during two consecutive breeding seasons.
