WOMEN'S PHYSIQUE

OPEN WOMEN'S DIVISION • THREE HEIGHT CLASSES

A. Up to 5'4"

B. Over 5'4" and up to & including 5'6"

C. Over 5'6"

WOMEN'S MASTER DIVISION • 35 & OVER • ONE CLASS

Pre-judge: Quarter Turns and "MANDATORY" Posing Comparisons

Finals: 60 SECOND ROUTINE: CDs ONLY. Bring music to Friday Night Check-in.

Judging Criteria • 2 Piece Swimsuit

Women will be judged on symmetry, shape, proportion, muscle tone and beauty flow. Physique should display all of the above without compromising femininity and beauty or flow of physique. Excessive muscularity will be scored down accordingly. Competitors should have the overall aesthetics and look that is found in the FIGURE DIVISION except with a little more overall muscularity.

WOMEN'S FIGURE

OPEN WOMEN'S DIVISION • FOUR HEIGHT CLASSES

A. Up to 5'2"

B. Over 5'2" and up to 5'4"

C. Over 5'4" and up to 5'6"

D. Over 5'6"

WOMEN'S MASTER DIVISION • 35 & OVER • ONE CLASS • 45 & OVER • ONE CLASS

Judging Criteria • 2 Piece Swimsuit

The competitors will be brought out in their 2 piece swimsuit with heels in one or two lines for the quarter turns. The judges will score the degree of athleticism by assessing the degree of firmness, symmetry, proportion and overall physical appearance, including complexion, poise and overall presentation. **NO BODY OIL ALLOWED.** Thong suits are NOT ALLOWED.

WOMEN'S MASTER DIVISION • 35 & OVER • 2 HEIGHT CLASSES: UP TO 5'4" AND OVER 5'4" TEENS DIVISION • ONE CLASS

NOVICE DIVISION • THREE HEIGHT CLASSES

A. Up to and including 5'4"

B. Over 5'4 and up to & including 5'6"

C. Over 5'6"

TRUE NOVICE DIVISION • TWO HEIGHT CLASSES

A. Under 5'6"

B. Over 5'6"

Judging Criteria • 2 Piece Swimsuit

The competitors will walk on stage alone and perform their "Model Walk". Personal preference, wearing a 2 piece swimsuit and heels. The "Model Walk" consists of the following: Walk to center stage, stop and do front stance (pose), then a full turn and do a rear stance (pose), then turn to the front again. Competitors will then be brought out in a group and directed to do a front and rear stance. No side judging. Judges will be scoring competitors on balance, shape, and overall appearance, including complexion, skin tone, poise and overall presentation.

NO BODY OIL ALLOWED. Competitors will compete in a 2 piece swimsuit in which the bottom of the suit must be "V" shaped.

Thong suits are NOT permitted. Competitors can compete in an off the rack suit, however, all swimsuits must be in good taste.
