# ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION

GULF SHORES YACHT AND RACQUET CLUB CONDOMINIUM ASSOCIATION, INC.

(TO BE KNOWN AS GULF SHORES SURF AND RACQUET CLUB CONDOMINIUM ASSOCIATION, INC.)

The Articles of Amendment of the Certificate of Incorporation of the above-captioned corporation made and entered into on the 27th day of February, 1988.

#### ARTICLE ONE

The present name of the corporation is Gulf Shores Yacht and Racquet Club Condominium Association, Inc.

### ARTICLE TWO

Item I of the Certificate of Incorporation is amended by deleting in its entirety the text thereof, and substituting the following:

"The name of the corporation shall be Gulf Shores Surf and Racquet Club Condominium Association, Inc. The corporation is herein referred to as the 'Association'."

## ARTICLE THREE

Item VIII of the Certificate of Incorporation is amended by deleting in its entirety the text thereof, and substituting the following:

"The property, business, and affairs of the Association shall be managed by a Board of Directors which shall consist of such number not less than three (3) nor more than five (5) as shall, from time to time, be determined and fixed by a vote of a majority of the voting rights present at any annual or special meeting of the members. Directors may be designated or elected and removed, and vacancies on the Board of Directors shall be filled as provided in the By-Laws. All the duties and powers of the Association existing under the Acts, the Declaration, these Articles, and the By-Laws shall be exercised exclusively by the Board of Directors, its agents, contractors, or employees, subject only to approval by unit owners when such approval is specifically required by the Acts, the Declaration, these Articles, or the By-Laws. The initial Board of Directors

shall be composed of three (3) members. The names and addresses of the three (3) members of the initial Board of Directors, who shall hold office until election or appointment of their successors, are as follows:

#### ARTICLE FOUR

Item XI of the Certificate of Incorporation is amended by deleting in its entirety the text thereof, and substituting the following:

"The registered office of the Association is West Gulf Shores Boulevard, Gulf Shores, Alabama 36542, and the name of the agent at that address is Kerry O'Connor."

ARTICLE FIVE
