May Monthly Report

For the month of May, we had 13 new Utility Customers in Garnett. We had 204 Delinquent Notices mailed out for not paying by the 15th of the month. Out of 204 delinquent notices, we had 26 utility customers who did not pay by the 25th of the month however 0 were shut off due to COVID-19 and Governor Kelly's Executive Order 20-05. Just as we did last month, I drafted a letter and printed it out on bright neon green card stock and I had our Meter Reader Shane Henkle go around to the 26 customers who hadn't paid and had him tape the letter to their doors.

We continue to work toward getting the online camping reservations up and running. There are a few things that need to be edited and corrected however it is coming together quite nicely and will be a great tool to have once implemented. Our goal right now is to do a soft roll out after Cornstock this year to catch some late campers as our test subjects and work out any bugs that may exist before the next camping season.

Recently JD Mersman reached out to me regarding expenses we have incurred due to COVID-19. I have been compiling invoices and receipts for all expenses and to date we have spent close to \$4,000. This figure does not include any labor hours for time spent in meetings and on conference calls related to the virus. Originally, JD was going to submit one project to FEMA that would include everyone within the county as there was concern about meeting the \$3,200 project mark however with us exceeding that number, he will be filing our project separately.

Also, this past month, several of us have been compiling data for our 2019 Audit. Jenny Schooler, Nancy Hermreck, and I have been working with the auditors to provide them with all they are

asking. We were able to knock out the list of items they requested before the audit began as well as several requests throughout the month. Due to COVID-19, all of these requests were done via email correspondence. A lot of scanning and emailing went on to get this accomplished which was not the easiest and most convenient on some things however we succeeded in getting them everything they requested. I want to thank both Jenny and Nancy for their hard work on getting it done quickly and efficiently.

1. Completed May Commission Report
2. Did Fuel Transactions and Invoices. Still learning the FuelMaster system.
3. Sent May Weather Data to the National Weather Service.
4. Reviewed and updated Based Aircraft on FAA website.
5. The AWOS system failed again. Jerry Miller came and the two of us worked on it and found that it was full of ants and mice. They had chewed the wiring on the main system and the battery backup. We replaced the wiring, battery, controls and cleaned everything. It is working well now, but it is on its last legs.
6. Disconnected the old Windows 7 system that was in use at the airport from the internet. I still have to connect it to the internet once a month to access and report the Fuelmaster system. I also hooked up and switched everything over to the newer system.
7. Bill Dempsey's plane left for Rantoul and that eliminated our long term aircraft situation.
8. The Fairfields are actively moving the aviation related equipment into their new hangar #7.
9. Fuel sales have picked up fairly robustly. We are still behind from the last couple months.
10. We have had two aircraft spend about a week tied down during construction of the new taxiway at Miami County airport.
11. Continued work on the process with the FAA project under the CARES Airport Act. Chris, I and Caleb Coltraine are working to come up with the best design for the airport and the community at the smallest cost.
12. All mowing equipment is working well and mowing is pretty much continuous.
13. Starting the second round of spraying weeds.
14. Both Dale Pense and Lynn Davidson have started spraying for the year.
15. The FBO is fully open now.
16. Kept organizing the records. It is going to be an ongoing project.
17. Finished organizing the Airport Advisory Board meetings for the last 25 years into notebooks. Once this pandemic is over, the board needs to go over them. There is a lot of great information and history in them.
18. We are transitioning back to in person meetings for the June Advisory Board meeting. Zoom will still be available.
19. Working on the airport budget.
20. Debating adjusting the fuel price to be more competitive with local airports. Currently \$3.65.
21. I continued updating the Facebook airport page with daily Hi/Lo temps and rain totals.
22. Total moisture for May was 6.10 inches.
23. Average High temp/ Low temp = 71.2/ 51.5

Flight Activity

Transient flights are starting to pick up.

A new aircraft has located at the airport. A very nice Citabria has taken the last open hangar at the airport.

Community Development & Tourism Report

As we “Open Garnett Again”, there are many tasks that keep us busy in relation to Community Development and Tourism. The computer keyboard has been “smokin’ hot” as we make change after change on our website and social media channels to keep up with the Governor’s order, then plan, then guidance. It’s a lot to keep citizens aware of. We have been working with Anderson County Emergency Management, the County Health Officer and the Anderson County Covid-19 Task Force, to post information they provide us through this process and share with the newspaper. You can follow some of the history of the last 3 months on our website by viewing three web pages ([Coronavirus](#), [Begin to Reopen](#), and [Open Garnett Again](#)) beginning on March 13th.

Last weekend was a busy weekend for Garnett. The Garnett Enduro Club hosted the kart road races. Organizers reported 50 racers on Saturday and 45 on Sunday. This was a great turnout with some new races coming to Garnett for the first time. Some of the participants came for Arkansas, Iowa, Oklahoma and Texas.

As of this writing we head into yet another busy weekend with the Southland Cruisers 4th Annual Classic Auto Show on the town square, the Kansas City Karting Association sanctioned sprint track races at Lake Garnett Sprint Track, and the Kansas Dual Sport Safari hosted by the Garnett Lions Club. All the events have expressed their desire to promote social distancing and adhering to CDC guidelines with all participants and spectators. We expect all these events to be well attended.

I created a tribute video to the ACHS Class of 2020 that was shown on our Facebook page at 2 p.m. on Sunday, May 10th, the time and day graduation would have taken place. Not knowing at the time this the class would get a real graduation ceremony, tentatively scheduled for June 29th at 8 p.m., we wanted to show those young men and women their city cares about them.

Memorial Day weekend was busy, thanks to Mr. Troy Hart, who organized an Honor Ride on Saturday, May 23rd to show respect to the Garnett Remembers patriotic banner honorees. The motorcycle ride consisted of members and guests of the American Legion Riders Chapter 156 that rode the banner route and included riding through the parking lots of Guest Homes Estates, ACH Residential Living Center and Parkview Heights Living Center. Those facilities brought some of their residents out to wave at the riders as they passed by. Kris Hix, City Admin/Chamber Director, and I took photos and video of the experience for use on our social media channels and future uses.

While the public Memorial Day ceremony was cancelled, I met Clarence Hermann (VFW), Jonathan Hall (Pastor-Church of the Nazarene), and Sarah Mader, trumpet player, at the Garnett Municipal Cemetery at 10 a.m. on Monday, May 25th and livestreamed a simple ceremony with gun salute and Taps. Chelsey D’Albini provided a video of a story that tied an earlier pandemic to

soldiers buried in our cemetery. I created a video around that clip she provided me and shared it online, and also on our website. And, the three times I visited the cemetery it was buzzing with traffic. Kudos to the Parks Department. The cemetery looked beautiful.

Congratulations to Pat Tate on his retirement as Fire Chief and Code Enforcement Officer. We took pictures of the retirement party that was most creatively organized by Desiree Donovan, Administrative Assistant to the City Manager, with a nice slideshow and refreshments.

The Chamber Players Community Theatre has released information on rescheduling their March performance to June 18-21. Coming soon to the Commission will be a request from the Lake Garnett Grand Prix Revival for Transient Guest Tax Funds. Events are doing what they can to make great things happen for Garnett. We received another TGT disbursement in May. It was slightly higher than the amount received one year ago for the same time period.

The Government Access Channel, Channel 20, has been down for the last 3 weeks. Vyve reports that a part has been on backorder and is to be installed tomorrow, so hopefully it will be back online soon.

The speaker system on the square is still not usable for events to plug into as a P.A. system. The weather, then Covid-19 stay home order, and other issues have prevented Bo Harris from being able to come to Garnett. He hopes to come down soon. City Manager Weiner has another option if this cannot be completed soon. We do not have any organized events on the schedule for the town square, other than the Garnett Farmers' Market, until the Lake Garnett Grand Prix Revival in October. I strongly believe the speaker system will be up and running before then.

We are working with the Garnett Farmers' Market to try and grow the market with more vendors, concessionaires, food trucks and activities. We are inviting food trucks and entertainment, and we look to implement some games such as cornhole, giant checkers, chalk art, etc. I would like to see maybe in our future there be an outdoor movie occasionally, if we can find a sponsor or other funding. Kris Hix and I are working with the current vendors and the Land of Kansas on ways to promote the Garnett Farmers' Market as a destination. We understand some town square stores may stay open on Thursdays and offer "pop-up" shops to set up by their businesses to help give people more reasons to visit the market on Thursdays. Vendor fee to be a market vendor is only \$10 per week for a 10 x 15 space. Information is available on the [farmers' market link](#) on our website.

Libertyfest is slated for Saturday evening, July 11th. Due to Covid-19, we postponed the Celebration of Service recognizing the honorees of the Garnett Remembers Patriotic Banner Project to be held in conjunction with Libertyfest. We are waiting confirmation on the Community Band for this event, but the contract for the fireworks is in place. We invite the City Commissioners to once again name the names of honorees during the Celebration of Service, and if they wish, to help collect donations at the entrance to the park. We've enjoyed our time doing this and always appreciate the help. We anticipate the start of people arriving at 5 p.m., the Celebration of Service at 7 p.m., fireworks at sunset; approximately 9:15 p.m.

So far, since taking on Libertyfest, the fireworks display has solely been paid for by donations from organizations and individuals, collected through the Garnett Community Foundation. We hope we have the support of the community and those who attend, and that the generosity will continue. The date of July 11th was chosen for Libertyfest due to larger venues with larger budgets having first dibs on the 4th of July. Our budget for the fireworks is \$5,000.

Town Talk, the City's quarterly newsletter, will be mailed out by the end of June to everyone in our zip code and made available for viewing on our website.

The Southeast Kansas Tourism Region is planning a meeting in Independence on June 18th. We will be picking up the new Southeast Kansas Adventures & Day Trips Guides and catching up on regional tourism initiatives post Covid-19.

We had a report of something making humming and rattling noise at the Garnett Municipal Airport & that the taxiway, runway and the rotating beacon were not working. A colony of ants had moved in to the lighting contactors and were not allowing the contactors to close completely. Removed both contactors disassembled and cleaned, removed all the ants we could from inside the contactor box.

We had a gentleman from United Power Services Incorporated and do an infrared survey of parts of our system in key locations. He found 2 spots that were showing heat on the distribution system.

- 1- Was on top of an electric distribution regulator inside the north substation. Repairs have been made. Using the Garnett Fire Departments Scott Micro IR thermal imaging camera rechecked connections. No hot spots were found.
- 2- Is on a non-fuseable cutout, on a riser pole just outside Garnett Power Plant. Repairs were made. . Using the Garnett Fire Departments Scott Micro IR thermal imaging camera rechecked connections. No hot spots were found.

We had the opportunity to open the Recreation Center back up this past month and the number of people that are using it seems to grow a little every day. We have staff on duty right now the entire time the facility is open to make sure people are following the social distancing guidelines and cleaning on a regular basis. We have also blocked an hour off for just those in the high risk category for the virus. We will continue to open up more and more as we work through the phases of reopening. We are currently working on a plan for the next phase which begins Monday. In the meantime if you have not been to our RecDesk sight you need to visit. Sami has changed the format and we are now able to put out more information on the page and it a little more user friendly. Sami has been a true asset during the entire COVID shut down/reopening.

As you may already know the league decided to cancel the summer baseball/softball season. We are also working to put some things together for the kids to do this summer free of charge. We are looking at some camps, clinics and just some fun events for them to participate in while they are not playing baseball. We do have a few private teams that have decided to form and play this summer. We are working with them to use our fields for practices and games this summer.

Memorial Day was very successful at the cemetery this year. This is the first year in a few where a storm did not come in and blow the flags over or break poles. The guys worked very hard to make sure the cemetery looked nice and have received a lot of compliments on the work they did and have done in the past. This holiday also gave us the opportunity to use the new flag pole, if you have not been out and seen it please do it is very well done. We are going through some things that we have never seen before and we are making decisions that affect the summers of a lot of kids, parents, and others who just wanted to have a fun and relaxing summer. It is something that weighs on me every day and these are not decisions I take lightly or make a snap judgements on. Rest assured I am doing all I can to keep up with all the information that is coming out so I can make that informed decision. I know at the end of the day some will agree and some will not. The fact of the matter is we have to do what we think is right for our community.

We hauled 34.23 tons of sludge to the Anderson County Transfer Station. We received 5 loads of cleanup water from the Ethanol Plants yearly shutdown/cleanup.

I took my Wastewater Class 2 test and passed. Rusty completed his Operation of Wastewater Treatment Plants from the California State University, Sacramento.

We sent in a blower and grit removal pump to get repaired. We helped the parks dept. with the weed eating and putting up flags at the cemetery for Memorial Day.

With all the rain we've been getting lately, there were several manholes over flowing all over town. We were keeping track of which ones and how long each one was overflowing. We have to have this information when we fill out the state bypass reports that have to be sent in when this happens.
