




Conditions for the Validity of Fire NOC.

1. All the fire safety and means of escape facilities shall be maintained in good working condition at all times. Any lapse in this regard shall make the owner/management liable for action.
2. There should not be any change of Trade for which this License has been issued.
3. Building sanctioning authority may verify any deviation with regard to the construction/occupancy in the building. In case of any deviation, the Fire Safety Certificates stands null and void.
4. Water reservoir should always be kept full up to the brim:
 1. The entrance and exit and the water reservoir should always be free from any obstructions.
 2. Fire fighters shall be trained for operating fire fighting system and mock evacuation drills be conducted at regular intervals and record be maintained.
