RESOLUTION 2021 - 12

A Resolution Establishing a Lottery for Competing Medical Cannabis Dispensary License Applications

WHEREAS, the Legislature of the State of South Dakota has provided for the approval of medical cannabis dispensary licenses as defined by SDCL 34-20G-1, by the governing bodies of municipalities pursuant to SDCL 34-20G-58; and

WHEREAS, the City of Summerset Board of Commissioners has set the number of medical cannabis dispensary licenses at one (1), and the nonrefundable application fee for such licenses Twenty-Thousand Dollars (\$20,000), with a license fee of One Hundred Thousand Dollars (\$100,000) in the event the license is awarded; and

WHEREAS the City of Summerset Board of Commissioners wishes to make the licenses available to the public in a fair and impartial manner; and

NOW, THEREFORE, BE IT HEREBY RESOLVED that the City of Summerset Board of Commissioners makes the following rules applicable to the issuance of the new medical cannabis dispensary license:

1. Applicants may apply for the available license in accordance with South Dakota law and Summerset City Ordinance Chapter 119.03, by submitting an application packet to the City of Summerset.
Such application packet shall include the following:
 - a. **Medical Marijuana Dispensary License Application.** This must be completed fully and according to its instructions and bear the necessary original signatures. Photocopies will not be accepted.
 - b. **Non-Refundable Application Fee.** Certified check, cashier's check, or bank draft in the amount of Twenty Thousand Dollars (\$20,000).
 - c. **Deadline.** All applications for the medical marijuana dispensary license shall be received at the office of the City of Summerset in time to be noticed and heard at the next scheduled date for a regular meeting of the Planning and Zoning Commission.
 - d. **Recommendation by Planning and Zoning:** All applications shall then be considered by the Planning and Zoning Commission, which shall thereafter make a recommendation to the Board of Commissioners.
 - e. **Board of Commissioners:** The Board of Commissioners shall then consider the recommendations from Planning and Zoning. If there is more than one qualified and approved applicant a lottery shall be held as described in his

Resolution.

- f. **Lottery.** The names of those applicants who have submitted a valid application for the medical marijuana dispensary license and have been approved per the City Ordinance shall be drawn at random in an open meeting of the Board of Commissioners at a time to be set. All applicants' names shall be drawn in order to have a list of alternates.
2. In the event the applicant refuses to consummate the purchase of the medical marijuana dispensary license with the payment of the One Hundred Thousand Dollar (\$100,000) license fee, then in that event the license may be awarded to the next alternate applicant.
3. If there is not more than one application submitted for the medical marijuana dispensary license, then that license shall become available on a first-come, first served basis, subject to the statutory licensing terms regarding notice, hearing, and all license requirements. For purposes of this resolution, "first-come first-served" shall mean that the first fully and accurately completed application for off-sale license which is submitted to the City of Summerset with the application fee of \$20,000.00 in good funds shall be entitled to have their application noticed and heard in accordance with the medical marijuana dispensary licensing statutes and City Ordinance.

The following petitioner has applied to the City of Summerset under the provisions of the City of Summerset Zoning Ordinance #2 as follows:

Spring Valley Entertainment, LLC – Conditional Use Permit located at: The portion of Lot B of the East ½ of the NW1/4 of Section 25, Township 3 North, Range 6 East of the Black Hills Meridian, City of Summerset, Meade County, SD as shown on the plat filed in Plat Book 5 on Page 15, lying southerly and westerly of Out Lot 1, lying northerly and easterly of the Constitution Street right-of-way, lying southerly and easterly of Lot 4R in Block 1 of Summerset USA, and lying northerly and westerly of the northerly Independence Loop right-of-way, as shown on the plats filed in Plat Book 21 on Pages 290-291 and Plat Book 21 on Page 1 (referred to on said plats as “Remainder of Block 1”).

The applicant has requested a permitted conditional use for the following:

Property is currently zoned C-1 General Commercial:

The following uses shall be permitted in the C-1 General Commercial District:

- (A) Retail establishments, including incidental manufacturing of goods for sale at wholesale or retail on the premises, provided there are three or less employees engaged in the manufacture of the product.

Petitioner is asking for conditional use permit under 155.117 (E) – more than three employees engaged in the manufacture of the product.

(BB) Open storage uses which shall comply with the following requirements:

- (1) All open storage and display of merchandise, material, and equipment shall be screened by a solid fence seven feet high at the side and rear of the lot which abuts any residential district.

Petitioner is asking for conditional use permit under 155.117 (E) – that the product, including but not limited to granite and stone not be contained by a fence or similar structure but to be on display for customers to view. Scrap or waste or refuse generated by business may be required by the City to be kept behind a screened fence.

Said application was duly noticed in the legal newspaper, certified letters were sent to all property owners within two hundred and fifty feet (250”) and a sign noting that a conditional use permit request was posted on site ten (10) days in advance of the hearing. The City of Summerset Planning and Zoning Commission reviewed the application on the 26th day of October 2021 and it was recommended for approval to the Summerset Board of Commissioners.

ORDINANCE 2021-07

131.14 NOISE REGULATION AND LIMITATION

- A. The purpose and intent of this section is to protect, preserve and promote the health, safety, welfare, peace, quiet and tranquility for the citizens and persons or visitors frequenting the city through the reduction, control and prevention of noise which is disruptive and constitutes an annoyance to such citizens and persons.
- B. General Restrictions
1. A person or property owner may not:
 - a. Make or permit any disruptive noise or use sound equipment in public or outside between 10pm and 7am;
 - b. Operate construction equipment, tools or conduct construction activities between 7pm and 7am;
 - c. Operate sound equipment in a vehicle causing any disruptive noise or a discernible vibration twenty (20) feet from the vehicle.
 2. In addition to the specific prohibitions outlined in subsection B (Subsection 1), it is unlawful for any person to make, continue, or cause to be made or continued any loud or unusual noise so as to disturb the peace of the public, any neighborhood, any business operation, family, lawful assembly of persons or a person by committing any act or acts of disturbance within the City limits.
 3. Excessive Vehicle Noise and Dynamic Engine Braking:
It is unlawful for any person within the city limits of the City to make, or cause to be made, loud or disturbing or offensive noise with any mechanical devices operated by compressed air and used for purposes of assisting braking such as Dynamic Engine Braking Devices. (Commonly referred to as “Jake” brake).
 4. Penalty:
Any violation of this ordinance will be punishable by a fine of \$100 for each offense, in addition to the payment of any costs and/or restitution authorized by Summerset Ordinances and/or state law.


Dear Stagebarn District:

Please be advised that the City of Summerset is adjusting the sewer rates, and will be considering said adjustment at the next regular meeting of the Board of Commissioners to be held on Thursday, November 7, 2019. At that time, the City Commission will consider raising the rates applicable to the Stagebarn District by 8% per residence as allowed by Summerset Ordinances, to include the rate adjustment and surcharge. This rate change will be effective January 1, 2020.

Stagebarn District is not located within the City limits, and entered into a contract with Summerset on or about September 23, 2010, which allows for annual sewer rate adjustments. Please note that there has been no rate change since October of 2017.

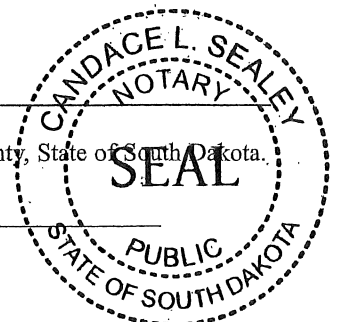

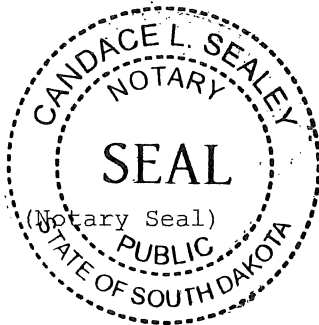
