**RESOLUTION AUTHORIZING THE APPROVAL OF A CONTRACT FOR THE PURCHASE OF REAL PROPERTY BETWEEN AMELIA VILLAGE AND THOMAS R. HATTON**

WHEREAS, Amelia Village, Clermont County, Ohio (the "Village") seeks to purchase certain property located at 45 Maple Street in Amelia, Ohio (the "Property") to be used for municipal purposes;

NOW, THEREFORE, be it resolved by the Council of Amelia Village, Clermont County, Ohio, that;

**SECTION I.** The Mayor of the Village is hereby authorized to execute the attached Contract to Purchase between the Village and Thomas R. Hatton in the amount of \$60,000.00 for the acquisition of the Property to be used for municipal purposes.

**SECTION II.** Council hereby finds and determines that all formal actions relative to the passage of this Resolution were taken in an open meeting of this Council, and that all deliberations of this Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION III.** This Resolution shall take effect at the earliest time permitted by law.
