Projects/Issues

November kicks MCCPTA's work on CIP advocacy into high gear, and we will work to ensure all of our clusters have the information and support they need to speak to the infrastructure and capacity issues of their schools. We will also continue to partner with MCPS to ensure everyone understands the new Key Facilities Indicators – which will inform the assessment of ALL MCPS schools, and the new process for identifying CIP project priorities. This month we will also focus

on ensuring all of our school communities are aware of the work to increase understanding and combat hate going on in our schools and communities – by community partners, MCPS divisions and student led intiatives. A goal is to ensure all schools have contacts and resources to start, grow, or continue the important work of making every MCPS student feel safe, valued and respected.

MCCPTA will also continue to work with MCPS to dig into the data reported on graduation 'college ready' criterion – as defined by the University System of Maryland – to see if there are patterns re: students receiving "D"s in core credits – by course, cluster, course sequence etc. – to see if that information provides information on how to better support students.

Kirwan:

The Kirwan commission has been meeting for over a year now, to evaluate Maryland's public school funding methods, and identify areas in which our schools need to innovate in order to serve our students better.

Policy recommendations likely to emerge in the final report go to drastically increasing the quality and availability of pre-K state-wide, and innovative ways to further professionalize the teacher workforce. The Commission is closely looking at states whose students outperform Maryland - Massachusetts, New Jersey and New Hampshire --- and also countries who spend less per student on education, but whose students appear to outperform US students.

The most current reports from Kirwan attendees and commission members seems to indicate that the Commission's required December report will focus on policy, and may not make funding recommendations, instead recommending that the Commission's work continue into 2018.
