## **OLD BUSINESS:**

Some board members have said there have been some complaints about the concession stand closing at 9pm on Monday nights. Counterman has agreed to stay later with the agreement snow cones, drinks, chips, and candy are the only items sold after 9pm and Counterman will close the concession stand after all games have finished. No hot food will be sold after 9pm.

Icenhower appointed Becki to run the concession stand for the remainder of the season.

The Soccer program was using Oncall as a contact source for getting information out on soccer. Counterman brought three bid options in for review. Sports Engine, it is a free app and will allow us to manage teams and send messages to all teams at once, Jersey Watch, will allow 1000 texts and emails charging 3% plus one dollar per transaction, Team Snap will allow us to create teams, free app for the community, saves all information for the next sport. Team Snap can be used to register for sports online and pay online. The Park Board was paying \$600.00 a month for Oncall for the use of soccer only. Team Snap is \$1800.00 a month and is available to use for all sports programs. Counterman spoke with Justin he would be our rep we would work with. Counterman said he does respond in a timely manner. He will create a website for the park Board.

The first two weeks of baseball the park has grossed \$2,179.00. \$71.00 was in discounts, hamburger/hotdog meal discount, volunteer meals, umpire meals. \$405.00 was made from credit card use. We have had several parents excited that we are now accepting credit/debit cards as payment.

Hotspot: Counterman did price checking. At&t, Version, Straighttalk, all run about the same price. \$65.00/month unlimited.

### **NEW BUSINESS:**

Alderman Danderson helped answer the question of how much can be spent without board approval. Anything under \$500.00, The Treasure and Chairman can speak with another board member and make the purchase. Anything \$501.00-\$1000.00 The Board would need to get three bids by phone or mail. When taking a bid they must include name, date, time, and the amount of the bid. \$1001.00-\$5000.00 can consist of phone or mail bid and would need to go before the board for approval, \$5001.00 or greater would need to be a sealed bid and taken before the board to open and review. The Park Board does not have to go with the lowest bid, but however the best contractor for the Park Board. The Park Board needs to have the State of Park Address turned into the Board of Alderman by the second Monday in June.

Anything that is Junk, hazardous, or a liability needs to be thrown in the trash. If there is an item the Park Board deems can be sold, then it should be sold Surplus, List the item, date bid ends, and contact info. We have the right to refuse any and all bids. Listing needs to be posted at City Hall and Facebook page.
