### **Financial Overview**

- The Parking Authority had YTD revenue as of May 31, 2025 of \$292,397. This is \$2,322 higher than the previous year. Total YTD expenses were \$169,147. A decrease of \$22,248 compared to the previous year. Net YTD revenue was \$123,251. An increase of \$24,570 compared to previous year.
- The Park and Ride had YTD revenue as of May 31, 2025 of 106,281. This is \$4,657 higher than the previous year. Total YTD expenses were \$83,167. A decrease of \$405 compared to the previous year. Net YTD revenue was \$23,115. An increase of \$5,063 compared to previous year.
