
A reminder that 2025 is a municipal election year in Alberta. Consider running for Council and remember to vote. It is your Summer Village and your community.

Assessment & Taxation

Where do your municipal tax dollars go?



Property Assessment

Each year, the Summer Village Assessor inspects certain properties within the Municipality. Property assessment estimates your property's market value as of December 31st of the prior year and is used to calculate property taxes. If you disagree with your assessed value, you have 60 days from the date of your assessment notice to file a complaint – **the deadline is Monday July 21, 2025**. A \$50 fee must accompany a completed complaint form, which is available on the Summer Village website or by contacting the office. Before filing your complaint, please contact the assessor, Travis Horne, at 780-939-3310 to discuss your assessment.

Property Taxes

The Summer Village collects revenue annually to meet the projected costs of providing services to the community. These revenues are primarily received through grants and municipal property taxes. The Summer Village also collects money on behalf of the Lac Ste. Anne Senior Foundation which is seeing a slight decrease from last year & the Alberta School Foundation Fund (education property tax) which is seeing a 10.2% increase from last year. This year's minimum municipal tax payable has been set at \$1,155.00 per property which is the same as last year. Property taxes are due Monday, June 30, 2025. The Summer Village has a monthly tax payment plan that runs from January to December. If you are interested in joining the plan, please visit the Summer Village website or contact the office.

If paying your taxes by mail or in person:

Please make cheque payable to the Summer Village of South View and mail to Box 8, Alberta Beach, AB, T0E 0A0. If paying in person, the office is located at 2317 Twp Rd 545, Lac Ste. Anne County.

If paying your taxes through telephone banking or online banking:

You are required to set the Summer Village of South View up as a "Bill Payment," the account number will be your "Tax Roll Number" as shown on your Combined Tax and Assessment Notice.

Register for South View Connect

Get important messages and **emergency alerts** from the Summer Village via email and text. **Register for South View Connect!** Go to the Summer Village's website and follow the registration steps. It is recommended that you sign up for both email and text as email is used for regular communication and texts tend to be used for more urgent matters.

Speed Limits in the Summer Village

Observing the Summer Village speed limits is necessary for everyone's safety. Speeding on Oscar Wikstrom Drive is a particular issue. The speed limit throughout the Summer Village is 30 km/hour and lanes/alleys are 15 km/hour.

NEW!

As of May 1, 2025 Community Peace Officer and Bylaw Enforcement Services are being provided by Lac Ste Anne County.

Bylaw Enforcement/ Community Peace Officer/ Animal Control/ RCMP

Lac Ste Anne County provides Peace Officer, Bylaw Enforcement, and Animal Control services to the Summer Village. You can reach them directly at 780-785-3630. For emergencies (Police, Fire, Ambulance), dial 9-1-1. Non-emergency RCMP line: 780-727-4446. Report any suspicious activity to the RCMP immediately with detailed information. New this year and in partnership with the Summer Village of Silver Sands, the Summer Village is participating in a trial enhanced RCMP policing program. You should see an increased RCMP presence during the summer months. We appreciate your feedback on this program.

Animal Control & Wildlife

All dogs within the boundaries of the Summer Village must be kept under control and on a leash at all times, including when in the park and reserve areas. There is currently no designated off-leash area for dogs. Please take responsibility for cleaning up after your animals, as many enjoy walking throughout the community. It is advised to feed pets indoors to prevent attracting unwanted wildlife. Further information can be found in the Animal Control Bylaw 250-2025, available on the Summer Village website.



Household Waste Bins

There are large waste bins situated throughout the Summer Village for residential waste. Please do not dispose of furniture, BBQs, tree limbs, shingles, or any renovation materials in these bins, as you may be held responsible for the cost of emptying them. Such items should be taken to the Regional Landfill Site located on Highway 43 and RR35, where the current disposal fee is \$60 per tonne. Additionally, there is a recycling depot that residents are encouraged to use. For further information, you may contact the site directly at 780-967-3466. To help conserve space in the Summer Village bins, please dismantle boxes, break down larger items, and empty grass clippings and leaves from their bags. Ensure all household waste is securely bagged. **Please note that there will NOT be a large bin event this year.**

FIRES HAPPEN! ARE YOU COVERED?



The cost of fire suppression by the fire department is payable by the property owner. In this area, the cost for a structure fire has been as high as \$28,000, and for a wildland (grass fire), as high as \$12,000. It is important to check your home insurance policy or speak to your insurance agent about what and how much your policy covers. In addition to inquiring about your home structure fire insurance, it is advisable to inquire about wildland insurance (for a grass fire that does not reach a structure). If the fire department is dispatched by 9-1-1 to your residence for any reason — including house alarms, campfires during a fire ban, fires deemed out of control or unattended, downed utility lines,

etc. – you, as the property owner, will receive an invoice. The only exception is for medical response calls (assisting Alberta Health Services) – there is no charge for these calls.

Fire Pits

All fire pits in the Summer Village of South View must:

- Be at least 3 meters (10 feet) from buildings, property lines and anything else that could catch fire.
- Be less than 0.6 meters (2 feet) high / Be less than 1 meter (3 feet) wide.
- Have enclosed sides made from bricks, concrete or heavy-gauge metal.
- Have a mesh screen on top to stop sparks (spark-arrestor) with openings smaller than 1.25 centimeters (1/2 inch).

Fire Bans

Bylaw 246-2024 Fire Bylaw regulates fires, fireworks, and the use of Off-Highway Vehicles (OHVs) (in relation to fire bans); all bylaws can be found on the Summer Village website. Please note that the Summer Village of South View is currently rewriting the Fire Bylaw. Keep an eye on the Summer Village website and sign up for emails to stay informed.

The Summer Village has three stages in relation to fires:

- 1. No Fire Ban or Advisory –fireworks, OHVs, and recreational fires are permitted in an approved firepit or portable appliance.
- 2. Fire Advisory OHVs and recreational fires are permitted in an approved firepit or portable appliance. Fireworks are PROHIBITED during a fire advisory.
- 3. Full Fire Ban no fireworks, OHVs, or recreational fires are permitted. Fires contained within approved portable appliances are permitted so long as all open flames are contained withing the appliance and no sparks are generated.



Fire Smart & Your Yard

Although there is always a risk, there are effective measures you can take to protect your property from fire damage or destruction. FireSmart Alberta (firesmartalberta.ca) promotes activities that enhance the resilience of your property. A simple cleanup of your yard, including removing fine light fuels such as dry leaves, grass, and branches, significantly helps in safeguarding your property against fires.

To support FireSmart initiatives, South View is organizing a **FireSmart Summer Village Cleanup and Potluck BBQ on July 19th. We need volunteers** for targeted cleanups to remove deadfall and fire hazards on Village property. East End Bus Society



The Lac Ste. Anne East End Bus Society provides affordable transportation to seniors (50+) and people living with disabilities in the east end of Lac Ste. Anne County. This service consists of scheduled shopping trips to West Edmonton Mall, St. Albert and Spruce Grove, monthly excursions funded by FCSS dollars and rentals by service clubs, special interest groups and community members.

Darwell Lagoon Commission Update

The Darwell Lagoon Commission (DLC) owns and operates the sewage lagoon near Darwell. The DLC is an independent entity whose members consist of Lac Ste Anne County and the Summer Villages of South View Silver Sands. The DLC is spearheading an expansion of sewage transmission and collection systems in the region. It is anticipated that Phase C of the expansion will see transmission and collection lines run through the Summer Village of South View. We are not yet sure what this means for our community. However, residents can anticipate public engagement from the DLC via mailouts and open houses. While the DLC is responsible for the expansion and associated communications and public engagement, South View Administration will endevour to keep residents and property owners updated through the Summer Village Website and emails through South View Connect.

2025 is a Municipal ELECTION YEAR

Running for Council is a great way to get more involved in your community! Councillors are key community builders who are an integral part of summer village planning. If you have a vision of what you believe the Summer Village of South View could look like in the next 5, 10, 15 years, this is your chance to help set the direction.

While it takes some effort, serving on Council is rewarding and a great way to learn and give back to the community.

The Summer Village of South View has 3 Councillors, and they elect a Mayor from among themselves – all three positions are up for election/re-election. To be eligible to run in the election you must be a resident, property owner, or spouse of a property owner in South View. For those interested in running for Council, there will be an optional **Candidate Information Session on May 24 at the Darwell Interlake Golden Age Club (Seniors**

May 9th – Tax & Assessment Notices are mailed
June 30th – Property taxes are due
July 1st – 2% Penalty on current taxes
July 19th – FireSmart Clean-Up Day
July 21th – Assessment Complaint Deadline
August 1st – 4% Penalty on current taxes
September 1st – 6% Penalty on current taxes
October 1st – 6% Penalty on current taxes
January 1st – 18% Penalty on outstanding taxes
