MONTHLY FEE PAYMENT INSTRUCTIONS

Prairielands pricing is \$0.20 per 1,000 gallons used.

Payment Calculation:

For the monthly reporting period, take metered usage, divide by 1,000; then multiply by .20.

(Example: If usage is 10 million gallons, calculate as $10,000,000 \div 1,000 = 10,000 \times .20 = \$2,000$)

For water systems that meet requirements of the District Rule 2.3, a **3%** water reduction can be claimed.
