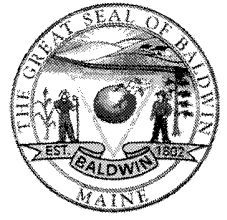

◦ **Cemetery Maintenance**

Casey Babbidge came in to discuss the cemetery concerns. He explained in his opinion which ones need maintaining, the flags in veteran cemeteries, the outlying cemeteries that need to be cleaned out. - **Boston Cane transfer to Historical Society** - Selectmen gave original cane to Kurt Olafsen to store at the historical society. Will send policy to historical society.


