The Project consists of selective site demolition as required to perform the work; excavating and hauling soil; and hauling, spreading, and compacting borrow to attain design grades for the construction and placement of roadways, concrete, buildings, utilities, and other marina equipment and facilities. Asphalt paving including hauling, placement, and compaction of base course, binder and surface asphalt layers. Cast-in-place concrete will be placed for sidewalks, curb and gutter, steps, floor slabs, structural foundations and walls, and other landscaping and storm water management. The work includes installation of docks and pier piles, and installing water, electric, and sewer utilities to support the marina operations. Harbor electrical utilities include dock utility centers and lighting. The work includes installing marina building structures including an office/storage building and marina restroom. Site restoration and storm water controls are part of the work and includes finish grading, placing topsoil, seeding, landscaping, installing and maintaining erosion controls, and installing facility storm water systems. Work shall commence immediately upon award on October 2, 2018, and the work shall be substantially complete by June 15, 2019.
