Ordinance O-2018-22

**AN ORDINANCE HIRING CHARLES KILGORE FOR THE POSITION OF
MAINTENANCE WORKER 1 AND DECLARING AN EMERGENCY**

WHEREAS, the Council of Amelia Village (“Village Council”) seeks to hire a new maintenance worker; and

NOW, THEREFORE, BE IT ORDAINED by the Council of Amelia Village, Clermont County, Ohio as follows:

SECTION I. Village Council hereby hires Charles Kilgore as an at-will full time employee to work in the position of Maintenance Worker 1 at a rate of \$17.00 per hour.

SECTION II. That the Amelia Village Council finds and determines that all formal actions relative to the passage of this ordinance were taken in an open meeting of this Council, and, that all deliberations of the council and of its committees, if any, which resulted in the formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION III. This Ordinance is declared to be an emergency measure necessary for the immediate preservation of the public health, safety and general welfare of Amelia Village and its inhabitants. The reason for the emergency is to ensure uninterrupted family health insurance coverage for Village employees who elect to purchase this option. Therefore, provided this emergency clause receives the affirmative vote of two-thirds of all members of Council this Ordinance shall take effect and be in force immediately upon its passage and approval by the Mayor, otherwise from and after the earliest period allowed by law.


