## Approval of Agenda

## **NWSISD Programs and Other Reports**

- 1. <u>Executive Director Report</u>: Jordan reported interviews were held for the Magnet School Coordinator position as part of the federal grant award. Jordan also reported that NWSISD has been experiencing service problems with its current benefits broker and may look for a new provider.
