A Memory of Childhood in Cayman Brac

When we were in Cayman Brac in 2018, we passed by this store. It was formerly owned by Britton Bodden Grant. Britton's mother was named Hannah, so he called the store Hanson Department Store.

At Christmas, we children used to gather between the store and the Bluff to set off fireworks. The stairway, which led up to Hanson Theatre, was often crowded as we waited for the movie to start.

One evening, I was on the stairway, and Wendy (Wendol Henry, Jr.), who was a nephew of my mother's friend Josie Carter, was standing some steps above me. He spit, and some of the spit landed on me. I warned him that there would be consequences if he did it again. He did, and I beat him up, even though he managed to bite me on my arm. It was not quite a fair fight, though, since I was bigger than he was.

Many years later, he drowned, so I heard. R.I.P., Wendy: I'm sorry I didn't get to have a friendly talk with you in our later years. Hanson Theatre/Department Store will be demolished next Tuesday.

Spend an Evening with Tim O'Brien, Author of "The Things They Carried"

2020 NEA Big Read concludes with presentation by award-winning novelist

The Hillsborough County Public Library Cooperative will present a special virtual evening with American novelist Tim O'Brien on Friday, Dec. 4 at 6 p.m.

O'Brien is the author of "The Things They Carried." The collection of linked short stories about a platoon of American soldiers fighting on the ground in the Vietnam War is based upon his experiences as a soldier in the 23rd Infantry Division.

The author's personal appearance caps the library system's participation in the 2020 NEA Big Read, which invites residents to find out for themselves how the joy of sharing a good book can bring a community together. The NEA Big Read is funded by a grant from the National Endowment for the Arts in partnership with Arts Midwest. Library staff chose "The Things They Carried" from the grant list in tribute to Hillsborough's significant military ties: In addition to being home to MacDill Air Force Base, Hillsborough has the most veterans in Florida.

During the free online event on Dec. 4, O'Brien will discuss "The Things They Carried" and his experiences during the Vietnam War, and answer questions from the audience. Go to HC-PLC.org to register and obtain the online link for the event. The presentation is sponsored by the Friends of the Jimmie B. Keel Regional Library.

Copies of "The Things They Carried" – which has a mature theme best suited for older teens and adults – are available at libraries and as an eBook on OverDrive. The library system also has organized an online book discussion on Monday, Nov. 30 at 6:30 p.m. Register at HC-PLC.org.

About "The Things They Carried" and author Tim O'Brien:

"The Things They Carried" (1990) is considered one of the finest books about the Vietnam War. Far from a combat story of pride and glory, it is a compassionate tale of the American soldier, brimming with raw honesty and thoughtful reflection. This award-winning work is a brutal, sometimes funny, often profound narrative about the human heart, how it fares under pressure, and what it can endure.

Author Tim O'Brien was born on Oct. 1, 1946. He earned a degree in political science from Macalester College. He spent his Vietnam tour of duty from 1969 to 1970 as a foot soldier with the 46th Infantry in Quang Ngai province before returning home with a Purple Heart after being wounded in a grenade attack. O'Brien published his first book to wide critical acclaim in 1973. He went on to write several award-winning books and win literary accolades, including a National Book Award and two National Endowment for the Arts fellowships. A resident of Austin, Texas, he teaches creative writing at Texas State University.

Blessing of the Creche at Franciscan Center

Tampa, Florida - All are welcome at the Franciscan Center's annual "Blessing of the Creche" on Friday, December 11th at 7:00 pm on the Center grounds at 3010 North Perry Avenue, Tampa. We'll provide cookies, cider, and caroling, and we encourage guests to bring their nativity scene figurines to be blessed by the Franciscan Friars of Sacred Heart Parish in Tampa. We also invite you to bring an unwrapped gift for mothers and infants that volunteers will deliver to the Dawning Family Services and Life Pregnancy Center in Tampa.

This blessing event is an annual tradition at the Franciscan Center. St. Francis of Assisi commemorated the birth of Jesus with a live nativity scene in 1223. Villagers came to gaze at the nativity as Francis preached about "the babe of Bethlehem." Legend also claims that the hay used by Francis miraculously

acquired the power to cure local cattle diseases.

Crèche is the French term for a Nativity, manger, or crib scene. Today it is common to have a crèche in the church during the Christmas season. Many Christian families also have crèches in their homes or on their front lawn as Christmas decorations. In some localities, crèches are on display in the town square, a park, or some other public place.

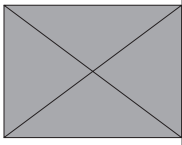

Nine Hillsborough County Library Locations Reopen

Throughout pandemic, all library services available virtually

Nine Hillsborough County libraries reopened with restrictions on Nov. 16, giving patrons direct access to materials including books and computers.

The County's 27 locations closed in late March to comply with COVID-19 precautions. Tropical Storm Eta briefly delayed the reopening as emergency managers and County officials prepared for potential impacts.

Here are Hillsborough County Public Library Cooperative (HCPLC) locations that are open, followed by their hours of operation and temporary restrictions:

- Bloomingdale Regional Public Library, 1906 Bloomingdale Ave. in Valrico
- C. Blythe Andrews, Jr. Public Library, 2607 E. Dr. Martin Luther King, Jr. Blvd. in Tampa
- Jan Kaminis Platt Regional Library, 3910 S. Manhattan Ave. in Tampa
- Jimmie B. Keel Regional Library, 2902 W. Bearss Ave. in Tampa
- Maureen B. Gauzza Public Library, 11211 Countryway Blvd. in Tampa
- New Tampa Regional Library, 10001 Cross Creek Blvd. in Tampa
- North Tampa Branch Library, 8916 North Blvd. in Tampa
- SouthShore Regional Library, 15816 Beth Shields Way in Ruskin
- Town 'N Country Regional Public Library, 7606 Paula Drive, Suite. 120 in Tampa

The buildings are available to the public from 10 a.m. to 6 p.m., Mondays through Saturdays.

Designated areas within these libraries are open at 25 percent capacity, with required safety protocols such as the wearing of masks and social distancing. Other safety measures include:

- Visits are limited to one hour.
- Children under age 17 must be accompanied by a parent.
- Temperature checks are conducted at the door.
- Study rooms, meeting rooms, makerspace, and recording studios are not available.

In a virtual sense, the County's libraries never closed. Throughout the pandemic all HCPLC services were available. Patrons could download books, movies, and music, and ask to have books mailed to their homes. The libraries saw a spike in attendance of virtual classes with people working from home, seeking to improve skills or learn new ones, and looking for things to do.

Health experts, emergency managers, Hillsborough County officials, and HCPLC leaders approved reopening in a limited capacity. More library branches, including the John F. Germany Public Library at 900 N. Ashley Drive in downtown Tampa, will reopen as part of the library's phased reopening plan.

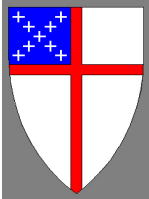

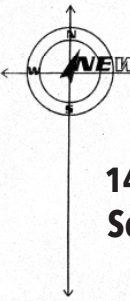

Geico Skytypers Air Show Team To Perform At The Sun N' Fun Holiday Flying Festival And Car Show

Renowned WWII Air Show Team to Perform Formation Flyovers on Fri. and Sat., December 4-5 (LAKELAND, FL) The GEICO Skytypers Air Show Team, the leading vintage airshow performance squadron, will be performing at the Sun N' Fun Holiday Flying Festival and Car Show on Friday and Saturday, December 4-5 at Lakeland Linder International Airport, 900 Don Emerson Dr, Lakeland, FL. The year marks the 75th Anniversary of the end of WWII and the GEICO Skytypers vintage airplanes trained the "greatest generation" of pilots for WWII.

ABOUT THE AIRCRAFT (SNJ)

- The GEICO Skytypers fly six WWII SNJs, the Navy's equivalent of the Texas T-6. Both trainer aircraft were used to prepare pilots of "The Greatest Generation" for combat.

- A computer located in the lead aircraft sends radio signals to the other planes and their white puffs of smoke create the "skytyped" messages that are often as tall as the Empire State Building and seen from a 15-mile radius.

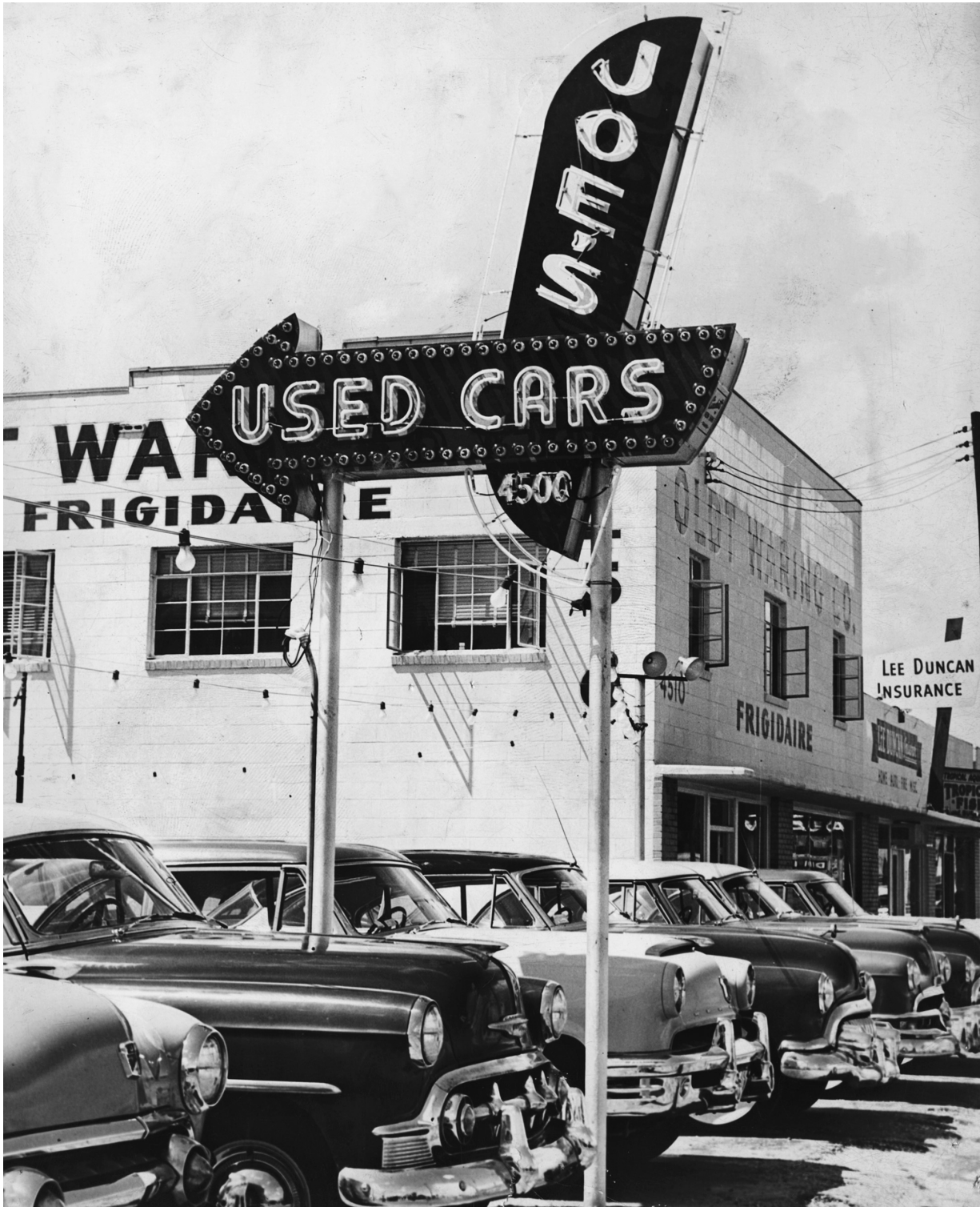

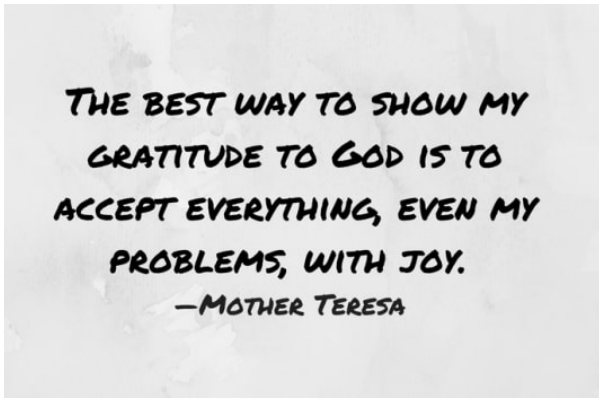

Spring Hill Man Reaches 150 Gallon Donor Milestone



71-year-old Tom Middleton donated platelets today and joins the ranks of less than 25 Floridians who have reached the 150 Gallon Donor milestone since blood banking began during the Second World War. He has helped to save or sustain many hundreds of lives and families.

Tom donated whole blood for the first few times in the early 1970's when they had a blood drive at work. A few years later he saw people donating platelets and discovered that his B positive blood type made him a perfect candidate to join them. Over the past 50 years Tom relocated to 38 different US cities for work and donated platelets in each one. He was especially motivated 40 years ago when the Blood Center in Toledo Ohio asked him to donate three times in one week for a cancer patient that was only responding to his platelets. Tom was told the patient went into remission afterwards. Just recently, Tom has been a best match for a cancer patient in Jacksonville Florida and has given platelets three times so far for them.

The need for blood and platelet donors became even more personal in Tom's life when over the years, his wife's father battled leukemia, as well as her two brothers. "Others helped them fight their battles by donating where they lived and I am doing the same here," said Tom. "I can't do a lot for people, but this is something I can do. What's a few hours to make a long term or permanent impact on someone's life?"

Generally, healthy people age 16 or older who weigh at least 110 pounds can donate blood. All donors receive a wellness checkup of blood pressure, pulse, temperature, iron count and cholesterol screening, including a Covid-19 Antibody Test, plus a surprise gift.

Sherry Cherry Pork Loin Roast

Prep time: 20 minutes
Cook time: 5-6 hours
Servings: 8-10

- 7 tablespoons avocado or grapeseed oil, divided
- 2 large Vidalia onions, halved and thinly sliced
- 4 teaspoons kosher salt, divided
- 1 pork loin roast (4-4 1/2 pounds), trimmed and patted dry
- 3 teaspoons freshly ground black pepper, divided

Sherry Cherry Sauce:
3/4 cup Holland House Sherry Cooking Wine
5-6 cloves garlic
1 cup frozen Bing cherries, divided
1 1/2 tablespoons dry mustard powder
4 tablespoons Holland House Balsamic Vinegar
2 tablespoons soy sauce
1 bunch fresh parsley, large stems removed, plus additional reserved for garnish
3 tablespoons cornstarch (optional)

In large slow cooker on high heat, add 2 tablespoons oil, sliced onions and 1 teaspoon salt.

Season roast evenly on all sides with 2 teaspoons salt and 1 teaspoon pepper.

Place large skillet over medium heat. Add 2 tablespoons oil to pan. Sear pork loin 3 minutes on each side until golden brown. Transfer roast to slow cooker on top of onions.

Cover and cook on low 3 hours.

To make Sherry Cherry Sauce: In blender, blend sherry cooking wine, garlic, 1/2 cup cherries, mustard powder, balsamic vinegar, soy sauce, parsley, remaining olive oil, remaining salt and remaining pepper until smooth; set aside.

- 4 cups chicken stock
- 1 cup Holland House White Cooking Wine
- 1 can (14 1/2 ounces) diced tomatoes
- 1 medium yellow onion, diced small
- 1 cup celery, diced
- 1 cup carrots, diced
- 6 large cloves garlic, minced
- 3 cans (15 1/2 ounces each) cannellini beans, rinsed and drained
- 1 can (13 3/4 ounces) artichoke hearts, rinsed and drained
- 1 bay leaf
- 1 teaspoon poultry seasoning
- 1 teaspoon salt
- 1 teaspoon ground black pepper
- 1/4 teaspoon dried rosemary
- 4 cups kale (about 6 ounces), cleaned, destemmed and chopped
- 5 ounces pancetta or bacon, diced
- 8 teaspoons Parmesan cheese, shaved (for garnish)

Place chicken stock, white cooking wine, tomatoes, onion, celery, carrots, garlic, cannellini beans, artichoke hearts, bay leaf, poultry seasoning, salt, pepper and rosemary in slow cooker. Cover and cook on low 7-8 hours or high 4-5 hours.

About 30 minutes before serving soup, stir in kale and cover.

In 10-inch skillet over medium heat, cook pancetta until crispy, about 4 minutes. Move pancetta to paper towel-lined plate to drain.

Ladle soup into bowls and sprinkle with pancetta and Parmesan cheese shavings.

Sherry, Ham and Cheese Brunch Bake

Cook time: 1 hour, 20 minutes
Servings: 10

- 8 tablespoons salted butter, melted, plus additional for greasing pan, divided
- 2 teaspoons olive oil
- 2 large shallots, minced
- 1/2 cup Holland House Sherry Cooking Wine
- 1 package (20 ounces) frozen hash brown potatoes

- 1/2 teaspoon salt
- 1/2 teaspoon pepper
- 2 cups (8 ounces) shredded white cheddar cheese
- 1 cup (4 ounces) shredded Parmesan cheese
- 8 ounces precooked ham, cut into 1/2-inch pieces
- 8 large eggs
- 1 1/4 cups whole milk
- 1/2 teaspoon dry mustard powder
- 2 tablespoons fresh chopped dill
- 1 teaspoon fresh chopped dill, for garnish (optional)
- 2 teaspoons freshly grated Parmesan cheese, for garnish (optional)

Move oven rack to middle position and preheat to 400 F. Generously grease 9-by-13-inch baking dish with butter; set aside.

In 10-inch nonstick skillet, add olive oil and preheat pan over medium heat. Add shallots and cook, stirring often, until softened and golden, about 7-8 minutes.

Stir in cooking wine and cook until liquid is evaporated, about 3-5 minutes. Remove from heat.

Add frozen hash browns to prepared baking dish. Pour melted butter over potatoes and add salt, pepper and caramelized shallots.

Use spoon to mix well. Bake 30 minutes, or until potatoes are cooked through and some edges are beginning to brown. Remove potatoes from oven and reduce temperature to 325 F.

Sprinkle cheddar cheese and 1 cup shredded Parmesan cheese evenly over potatoes followed by ham.

In large measuring cup or small bowl, vigorously whisk eggs, milk, mustard powder and dill until fully combined and eggs become frothy, about 1 minute.

Pour egg mixture evenly over potatoes, cheese and ham. Store covered in refrigerator if prepping night before.

Bake 35-40 minutes, or until edges of casserole are golden brown and center of casserole is set.

Cool 5 minutes before slicing and serving. Serve with chopped dill and grated Parmesan cheese, if desired.
