**Rental Agreement**

The rental agreement is made on the \_\_\_\_ day of \_\_\_\_ 2016, between McGee's Landing RV Park, with its principle office located at 1076 McGee's Landing Rd., Hemphill, TX 75948, referred to herein as Lessor, and (Guest) referred to herein as Lessee. Lessor leases to Lessee and Lessee leases from Lessor, for the term of this agreement, Cabin 1 or 2 of the McGee's Landing RV Park and being hereafter referred to as Cabin 1 or 2 and pursuant to the following terms and conditions.

1. **Rent:** Lessee agrees to pay as rental \$ \_\_\_\_\_ daily/weekly/monthly for Cabin 1 or 2 beginning \_\_\_\_\_ 2016, through \_\_\_\_\_ 2016 payable without demand, either by credit card, check or cash.
2. **Pets:** Lessee agrees to pay a \$25 pet deposit.
3. **Assignment and Subletting:** Lessee shall not sublet the Cabins, or any part of the premises, or assign this agreement.
4. **Default:** Any failure by the Lessee to pay rent or other charges promptly when due or to comply with any other term or condition of this agreement shall, at the option of Lessor, promptly terminate this tenancy and forfeit all rights of Lessee under this agreement.
5. **Governing Law:** This agreement shall be governed by, construed, and enforced in accordance with the laws of the state of Texas.

**RV Park Rules**

- Please observe a Speed Limit of 15 mph
- Quiet Hours 10 pm – 7 am. Please be considerate to others. No loud music during this time.
- ATV's and Recreational Vehicles allowed on the road only.
- There is a dumpster located in the middle of the circle drive going to the boat ramp. All garbage must be bagged and tied, boxes broken down. Cleanliness of the park is important to us.
- Pets must be maintained by leash. Owner must be in control of their pet at all times. If your pet exhibits any aggressive behavior you will be asked to remove them from the premises.
- Children must be supervised.
- Illegal drugs of any form are prohibited on the property of McGee's Landing. Person or Persons' caught in violation of this rule are subject to immediate eviction without a refund.
- All park facilities and equipment of the park is intended for the convenience of the guest. Any and all persons using the facilities do so at Their Own Risk and consent. The park management is not responsible for accidents due to fire, theft, wind, flood, personal negligence, acts of God or other unfortunate circumstances. The registered guest is financially responsible for all individuals or pets at their site for any/all damage to the park.

**Cabin Rules:**

\_\_\_\_\_ **Non-smoking** facility any evidence of smoking indoors will result in a \$100 fine charged to the lessee credit card on file after check out.

\_\_\_\_\_ **Cleaning** instructions are outlined in the Cabin book failure to clean properly will result in a \$25 charge to credit card on file after check out.

\_\_\_\_\_ **Inventory** will be taken after check out. Any damages or stolen items will result in a \$100 charge to credit card on file after check out.

Management reserves the right to refuse anyone, and make changes to the rules, regulations and fees when necessary. This property is under 24 hour video surveillance.
