Architectural Changes

Please remember that making visible changes to your home or property might require Board approval. If you are planning to make any changes to the exterior of your property, or major structural changes to the interior, please take a moment to review the Architectural Change requirements detailed in the CC&Rs. This can be found under Article C. An Architectural Change Request Form is available on the HOA's website, or can be requested by contacting a member of the Board.

Complaints

We wish to assist homeowners in resolving issues, while still attempting to maintain good relationships with neighbors. Since the Board doesn't patrol the neighborhood, we rely primarily on our neighbors to advise us when a CC&R violation exists.

As a policy, the Board doesn't release the name of the person who filed the complaint. A Complaint Form is available on the HOA's website or can be requested by contacting a member of the Board.

Landscaping on 53rd

During the annual homeowners meeting, we discussed issues regarding the upkeep of the common area along 53rd. Based on the input received, we will be consulting the City of Albany regarding the trees, which are causing damage to our sprinklers and the sidewalks. Our desire is to improve the quality of common area, maintain the green that we have, while still keeping our costs to a minimum. We welcome anyone interested in participating in the planning process to contact the Board.

Emergency Contact Number

We understand that not every homeowner has access to email or can reach our website to report an issue. For situations that require a quick resolution, the Board has set up a voicemail box to handle things such as: A tree (in the wetlands) is threatening your property; The common area fence has been damaged; Or someone was injured on our common area. Street Parking

This is just a reminder that Elk Circle doesn't meet City regulations with regard to curb striping. Please don't park directly across from another car as this can prevent a fire truck or ambulance from navigating the street. In the event of an emergency, we all want them to reach those in need. If your property is being rented to another party, please remember to provide the tenant with a copy of the CC&Rs. We also ask that the owner of the property manage any issues with non-compliance. Property owners are responsible for any penalty incurred by a tenant.
