

# Town of Baldwin, Maine SELECTMEN MEETING MINUTES TUESDAY, SEPTEMBER 10, 2019, 6:30 P.M.

**Attendance:** Selectmen: Dwight Warren, Jim Dolloff and Gerry Brown as well as members of the Public.

1. Selectmen Meeting was called to order approximately at 6:30 PM by Dwight Warren.

## 2. Review/ Approve meeting minutes

Dwight Warrent requested a motion to accept and approve August 27th, 2019 meeting minutes. Jim Dolloff made a motion, Gerry Brown seconded the motion; Selectmen voted 3-0 to approve meeting minutes.

## 3. Review/ Approve warrant

Dwight Warren requested a motion to accept and approve September 10th, 2019 warrant. Jim Dolloff made a motion, Gerry Brown seconded the motion; Selectmen voted 3-0 to approve the warrant.

#### **New Business**

- <u>Barbara Lewis</u>: Barbara provided the Selectmen with a handout. They are concerned with the role of the CEO with regards to their boundary dispute. They referred to the Saco River Corridor Commission (SRCC) meeting, reported that Wes Sunderland was bias and the SRCC tabled the issue. Barbara and her sister requested a letter from the Selectmen regarding the boundary dispute and that Selectmen are acknowledging it's a civil matter. Selectmen will not provide a letter unless requested directly from SRCC. Barbara requested the CEO job description from the Selectmen and provided her email address.
- <u>Sand Pond:</u> Selectmen discussed and agreed to meet up and remove buoys from Sand Pond next week.
- <u>Assistant Fire Chief Appointment</u>: Selectmen recommended and voted 3-0 to appoint Bruce Crawford as Assistant Fire Chief for another 3 year term.

- <u>Ed MacDonald Safety Grant</u>: Selectmen reviewed safety grant application with Jason Brown. Asked Jason to look it over.
- Review revised security camera pricing Selectmen discussed, reviewed reduced quote and different DVR prices and the camera needs in the office. Selectmen want to check budgets with Debbie to see if the budget allows for camera purchase.
