Bloomfield Police Department Monthly Report for October 2018

This is the monthly report for the Month of October 2018 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

On Friday, October 5th at approximately 12:14am officers executed a traffic stop on Hwy 50 for an equipment violation. At the conclusion of the traffic stop a 23-year-old male was issued a traffic citation for operating without a valid driver's license. Additionally, the driver was issued a non-traffic citation for possession of marijuana.

On Monday, October 8th at approximately 11:08pm officers executed a traffic stop on Hwy 50 for a traffic infraction. At the conclusion of the traffic stop a 25-year-old male was issued a traffic citation for a speeding violation. Additionally, the driver was issued a traffic citation for operating after suspension.

On Wednesday, October 10th at approximately 7:31am officers responded to a personal injury roll over crash on Clover Rd in the area of N. Lakeshore Drive. At the conclusion of the investigation an 18-year-old male driver was issued a non-traffic citation for disorderly conduct with a motor vehicle. Additionally, the driver was issued a traffic citation for use of a phone while driving.

On Friday, October 12th at approximately 2:15pm officers responded to a report of criminal damage to property. The complainant reported two vehicles driving off the roadway through mud and standing water causing damage to the property. At the conclusion of the investigation two 17-year-old male drivers were issued non-traffic citations for criminal damage to property. Additionally one of the drivers was also issued a non-traffic citation for resisting/obstructing a police officer.

On Friday, October 12th at approximately 5:37pm officers executed a traffic stop on Nippersink Rd in the area of Powers Lake Road for a traffic infraction. At the conclusion of the traffic stop a 33-year-old male was arrested for two outstanding warrants. Additionally, the driver was issued traffic citations for operating after suspension and operating motor vehicle without insurance.

On Tuesday, October 16^{th} at approximately 12:40am officers responded to a report of a vehicle in the ditch in the area of Hwy 120 and Westside Road. At the conclusion of the investigation a 23-year-old male was arrested for operating a motor vehicle while intoxicated 1^{st} offense.

On Thursday October 18th at approximately 7:19pm officers responded to a residence on Pell Lake Drive for a warrant arrest attempt. At the conclusion of the investigation a 36-year-old female was arrested then turned over to the Kenosha County Sheriff's Department. A second 36-year-old female was arrested and confined in the Walworth County Jail. Charges of possession of cocaine, possession of a controlled substance and possession of drug paraphernalia have been forwarded to the Walworth County District Attorney's office for the second female.

On Thursday, October 25th at approximately 7:10am officers responded to a two vehicle personal injury crash at the intersection of Bloomfield Rd and North Road. At the conclusion of the investigation a 35-year-old male driver was issued a traffic citation for following too closely.

On Friday, October 26th at approximately 1:47pm officers executed a traffic stop on Hwy 12 in the area of Pell Lake Drive for a speed violation. At the conclusion of the traffic stop a 25-year-old male was issued a traffic citation for speeding on expressway (25mph-29mph over), operating after suspension and operating a motor vehicle without insurance.

On Sunday, October 28th at approximately 2:03am officers executed a traffic stop on Powers Lake Rd in the area of Nippersink Rd for a traffic infraction. At the conclusion of the traffic stop a 28-year-old male was arrested for operating a motor vehicle while intoxicated 1st offense. Additionally, the driver was issued a traffic citation for operating left of center.

On Tuesday, October 30th at approximately 6:02pm officers responded to a two vehicle personal injury crash at the intersection of Hwy 120 and Bloomfield Road. At the conclusion of the investigation a 44-year-old male was issued traffic citations for failure to yield right-of-way from a stop sign and operating a motor vehicle without insurance.

During the month of October 2018, the Bloomfield Police Department responded to 807 calls for service compared to 913 calls for service during the month of October 2017. During the month of October 2018, the police department affected 140 arrests for various violations of Bloomfield Municipal Ordinances and Wisconsin State Statutes compared 79 arrests during the month of October 2017.
