Supervisor May called the board meeting to order at 7:00 p.m. at the town hall located at 3529 Rt. 20A, Warsaw, New York.

Supervisor May opened with the Pledge of Allegiance; all were thanked for attending the meeting.

Supervisor May introduced Mr. Matt Fairchok to discuss the union MOU. Article 23 0 Health Insurance coverage – 20/20/0. New employee health insurance. Town Clerks Report:

The Towns total revenue for the month of September was \$2,203.00, \$430.00 for Zoning, \$306.00 for dog licenses, \$25.00 for late fees and \$1,442.00 for DEC. We had 3 new licenses and 26 renewal licenses. To the general fund, \$578.83, Dogs were \$97.00, Late fee - \$25.00, \$34.83 for DEC, and \$430.00 for Zoning. We disbursed \$170.00 to Wyoming County, \$39.00 to Ag and Markets for dogs and \$1,407.17 to the DEC.

The Town Board reviewed the tentative budget. We are still in need to the Varysburg Fire cost. On a motion by Mr. Herman, seconded by Mr. Flint to accept the tentative budget and move to preliminary, with a public hearing at the next scheduled Board Meeting November 3, 2022 at 7:30pm. Supervisor May requested a motion to approve the 2022 Highway Fund Bills: Abstract #10 vouchers #153 through 174 totaling \$421,243.15. A motion was made by Mr. Herman, seconded by Mr. Boxler to approve the payment of the Highway bills. Ayes [4] May Boxler Flint Herman Ahl. Noes [0] Carried

Supervisor May requested a motion to approve the 2022 General Fund Bills: - Abstract #10 Vouchers #191 through 212 totaling \$24,931.91. A motion was made by Mr. Boxler, seconded by Mr. Herman to approve the payment of the General Fund bills. Ayes [4] May Boxler Flint Herman Ahl. Noes [0] Carried
