With warmer weather we've been playing catch-up. When the baler was down and then the fork lift, we got a bit behind with baling. Now things are looking much better. We shipped a load of OCC/mixed paper today - \$85/ton for OCC and \$25/ton for mixed paper - to Canada.

Snow has melted and the solar panels are once again producing power. We didn't generate any power for about 6 weeks.

CMP - We've submitted our load sheet to CMP. Now we're waiting on them for a visit with one of their engineers and a quote.

I'm meeting with a rep from BHBT on Monday to discuss what they can do for us. Since we shifted our sales revenue funds from a standard savings account to a money market account in June, we've earned \$1285.45 in dividends.
